3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. LD : If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in

the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s). In all such cases GST would also be applicable on LD.

2. Participating bidder should submit unconditional acceptance of all bid conditions including scope of work, SLA, Payment Terms etc.
3. Non-discloser undertaking: - Participating bidder should submit non-discloser undertaking for not sharing the privacy of this organization (by bidder or their personnel) to other firms/person etc. by any mode of means.
4. The bidder firm has to submit the documents as per the below eligibility criteria and the evaluation will be done considering the same:-
 - a) Experience & Past Performance: The bidder should have experience of having successfully supplied the manpower services for at least 21170 man days in any one of the last five years ending on 31.03.2022.
 - b) Capability: The bidder must have capability to provide the relevant services.
 - c) Financial standing:
 - [i] The average annual financial turnover of the bidder during the last three years, ending on 31.03.2022, should be at least Rs. 1,55,74,894/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a **Chartered Accountant/ Cost Accountant** in India or equivalent countries.
 - [ii] The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31.03.2022.
 - [iii] The net worth of the bidder should not be negative on 31.03.2022 and also should not have eroded by more than 30% in the last three years, ending on 31.03.2022.

Note:-

1. Participating bidder needs to submit all related documents along with the bid.
2. MSE and Startups are exempted from eligibility criteria 4 (a) and (c) [i] as per MSE guidelines.
3. After accepting the contract, additional SD must be deposited by firm whenever financial implication would be amended due to minimum wages revision or increment of working days (i.e. 365 days in place of

360 days) or increment of manpower strength etc.

4. For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria

(i) Purchase Order copy along with Tax invoice(s) with self-certification

by the bidder that supplies against the invoices have been executed.

(ii) Any other document in support of order execution like work completion certificate etc.

5. Participating bidders should take a note of ATC clause regarding "Availability of Office of Service Provider: An office of the service provider must be located in the state of consignee. Documentary evidence to be submitted ." State of consignee for this bid is only Madhya Pradesh, hence bidder needs to submit appropriate valid document.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and

[Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
