4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 2. At the time of submitting the offer, bidder has to submit the following:

(B). Sealed and signed bid document as an acceptance of all additional terms and conditions of the bid without any deviation.

3. The bidder firm should meet following eligibility criteria to qualify:

A. Experience & Past Performance:

The bidder should have experience of having successfully completed similar works during last 7 years ending on 31st March, 2022:

- a. Three similar completed works each costing not less than the amount equal to Rs15,75,506.00.

or

- b. Two similar completed works each costing not less than the amount equal to Rs.19,69,382.00.

or

- c. One similar completed work costing not less than the amount equal to Rs.31,51,011.20.

B. Capability - Equipment & Manufacturing Facilities:

The Bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engineering Service (MES) or any other Government / PSU/ Autonomous bodies.

C. Financial Standing:

- a. The average annual financial turnover of the bidder during the last three years ending on 31st March, 2022, should be at least Rs.15,75,506.00 as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India.
- b. The bidder should not have suffered any financial loss for more than one year during the first three years, ending on 31st March, 2022.
- c.
- i. The net worth of the bidder should not be negative on 31st March, 2022 and also
- ii. Should not have eroded by more than 30% in the last three years, ending on 31st March, 2022.

4. Liquidated Damages:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

Note:

- (a). Participating bidder needs to submit all related documents along with the bid.
- (b). MSEs and startups are exempted from eligibility criteria 3(A) and 3(C)(a) as above under "MSME/ Registered under Startup Campaign Scheme."

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
