[i] The average annual financial turnover of the bidder during the last three years, ending on 31.03.2022, should be at least Rs.14,08,565.58/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Charted Accountant/Cost Accountant in India or equivalent countries.
