LD : If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

2. Participating bidder should submit unconditional acceptance of all the bid conditions including scope of work, SLA, Payment Terms etc.

3. Non-disclosure undertaking: - Participating bidder should submit non-disclosure undertaking fo

r not sharing the privacy of this organization (by bidder or their personnel) to other firms/person etc. by any mode of means.

4. The bidder firm has to submit the documents as per the below eligibility criteria and the evaluation will be done considering the same:-

a) Experience & Past Performance: The bidder firm should have experience to supply at least one similar services in any one year during last five years ending on 31.03.2022.

b) Capability: The bidder must have capability to provide the relevant services.

c) Financial standing:

[i] The average annual financial turnover of the bidder during the last three years, ending on 31.03.2022, should be at least Rs.14,08,565.58/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India or equivalent countries.

[ii] The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31.03.2022.

[iii] The net worth of the bidder should not be negative on 31.03.2022 and also should not have eroded by more than 30% in the last three years, ending on 31.03.2022.

Note:-

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
