OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

2. Non-disclosure undertaking: - Participating bidder should submit non-disclosure undertaking for not sharing the privacy of this organization (by bidder or their personnel) to other firms/person etc . by any mode of means.

3.Payment Terms : The payment shall be made to the contractor through RTGS/NEFT are subject t o deduction of tax(s), Cess livable by Government as per rules from time to time and will be made

after the completion of every month or completion of assigned work on 10th day of each month an d after certification by user department. The bill must be submitted in triplicate after disbursement among the workers within 5 days. Further, the agency shall furnish a copy deposition of monthly E PF/ESIC challan returns along with etc. with the bill falling which amount as deemed fit by Bank No te Press, Dewas shall with hold in the next subsequent bill. The payment must be made before est ate Custodian/Officer (HR) or GM BNP representative, which should be duly authorized by him.

4. The bidder firm has to submit the documents as per the below eligibility criteria and the evaluat ion will be done considering the same:-

a) Experience & Past Performance : The bidder should have experience of having successfully sup plied the manpower services for at least 2196 man days in any one of the last five years ending o n 31.03.2022.

b) Capability: The bidder must have capability to provide the relevant services.

c) Financial standing:

[i] The average annual financial turnover of the bidder during the last three years, ending on 31.03.2022, should be at least **Rs.17,18,594.53**/- as per the annual report (audited balance shee t and profit & loss account) of the relevant period, duly authenticated by a Charted Accountant/Co st Accountant in India or equivalent countries.

[ii] The bidder should not have suffered any financial loss for more than one year during the last th ree years, ending on 31.03.2022.

[iii] The net worth of the bidder should not be negative on 31.03.2022 and also should not have er oded by more than 30% in the last three years, ending on 31.03.2022.

5. LD : If the supplier fails to deliver any or all of the goods or fails to perform the services within the time f rame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies availabl e to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent t o the $\frac{1}{2}$ % percent of the delivered price of the delayed goods and/ or services for each week of delay or pa rt thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

Note:- (i) MSE and Startups are exempted from eligibility criteria 4 (a) and (c) [i] as per MSE guidelines.

(ii) After accepting the contract additional SD must be deposited by firm whenever fina ncial implication would be amended due to minimum wages revision or increment of w orking days (i.e. 366 days in place of 360 days) or increment of manpower strength etc

(iii) Participating bidder needs to submit all related documents along with the bid.

(iv) For fulfilling the experience criteria any one of the following documents may be considered as valid pr oof for meeting the experience criteria:

- i. Purchase Order copy along with Tax invoice(s) with self-certification by the bidder that supplies again st the invoices have been executed.
- ii. Any other document in support of order execution like work completion certificate etc.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
