- 1. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. - (C). The Participating bidder shall visit the site before bidding. The site visit certificate will be issue d by BNP authority and it is mandatory to submit the certificate along with the bid documents at the time of participation failing which the bid shall not be considered.

3. The bidder firm should meet following eligibility criteria to qualify:

A. Experience & Past Performance:

The bidder should have experience of having successfully completed similar works during last 7 ye ars ending on 31st March, 2022:

a. Three similar completed works each costing not less than the amount equal to Rs.26,57,803.0 0.

or

b. Two similar completed works each costing not less than the amount equal to Rs.33,22,253.00.

or

c. One similar completed work costing not less than the amount equal to Rs.53,15,605.00.

B. Capability - Equipment & Manufacturing Facilities:

The Bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engine ering Service (MES) or any other Government / PSU/ Autonomous bodies.

C. Financial Standing:

- a. The average annual financial turnover of the bidder during the last three years ending on 31st March, 2022, should be at least Rs.26,57,803.00 as per the annual report (audited balance sh eet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India.

4. Liquidated Damages:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SP MCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the % percent of the delivered price of the delayed goods and/ or services for each week of delay or part there of until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

- 11. Creating bid for items from irrelevant categories.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
