1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

- 3. **LD Clause:** If the supplier fails to deliver any or all of the goods or fails to perform the services with in the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and re medies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages , a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for e ach week of delay or part thereof until actual delivery or performance, subject to a maximum deductio n of the 10% of the delayed goods' or services' contract price(s).

6. Delivery Schedule:

For New Supplier: The firm has to supply & installation one battery powered strapping tool for testing wi thin 20 days from the date for GeM contract. If it is accepted, then the firm have to supply rest 05 tools wit hin 30 days from the date of acceptance.

For Proven Supplier: The firm have to supply & installation of the material within 30 days from the date of GeM contract.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 1. Battery Powered Strapping Tool should be suitable for the PET/PP strapping which details is as follows-

Strap: PET/PP

Strap width: 12MM to 16MM Strap thickness: 0.5-1.00mm

2. Joint Strenght: 75-80%

3. Tension Range: 0-2500N

- 4. It should have brushless motor system.
- 5. It should be Battery operated.
- 6. Battery should be fitted inside the tool and rechargeble with Charger.
