However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Certificates

3. Non-Disclosure undertaking:-

7. GST Return:

Supplier should file the GST returns for outward supplies in time. In case of any Input credit Loss to B NP by way of their failure to files GST returns in time, BNP reserves the right to withhold the paymen t of further supplies till production of evidence of filling of returns."

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
