Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Scope of Supply

B. **Capability, Equipment and Manufacturing facilities** : The Bidder must have an annual capacity to manufacture & supply at least 12800 Kgs of tendered item.
