#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the

Bid document, ATC and Corrigendum if any.

### 3. **Buyer Added Bid Specific ATC**

#### **1. Payment Terms:**

#### **2. At the time of submitting the offer, bidder has to submit the following:**

(A). Sealed and Signed Service Level Agreement and Scope of Work.

(B). Sealed and signed Bid document as an acceptance of all additional terms and conditions of the bid without any deviation.

#### **3. The bidder firm should meet following eligibility criteria to qualify:**

##### **A. Experience & Past Performance:**

The bidder should have experience of having successfully completed similar works during last 7 years ending on 31st March, 2023:

a. Three similar completed works each costing not less than the amount equal to Rs.1,55,685.00.

b. Two similar completed works each costing not less than the amount equal to Rs.1,94,605.50.

c. One similar completed work costing not less than the amount equal to Rs.3,11,369.00.

##### **B. Capability - Equipment & Manufacturing Facilities:**

The Bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engineering Service (MES) or any other Government / PSU/ Autonomous bodies.

#### **4. Liquidated Damages:**

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for e

each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

## **6. GST Return:**

Supplier should file the GST returns for outward supplies in time. In case of any Input credit Loss to BNP by way of their failure to file GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filing of returns.”

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
