- 1. Type:- Water Cooled Screw Heat Pump
- 2. Model:- KRISCRSW 3200-2HPCS
- 3. Capacity:- a) Heating 825 KW
- b) Cooling 160TR
- 4. AMC period :- 1 Year

Terms & Conditions:-

- 1) All the consumable materials / spares will be provided by BNP.
- 2) The contractor shall attend any complaint / breakdown of equipment (Heat Pump) within 24 to 48 Hours.
- 3) The contractor shall attend unlimited call during AMC period.
- 4) The service engineer shall visit once in 3 months (quarterly) total 4 services for preventive and corrective maintenance.
- 5) The first service shall be done within 30 days from the date of receipt of contract PO.
- 6) The Heat Pump shall be inspected by service engineer at least four times in a year at the regular interval. After each inspection and servicing of Heat Pump a copy of the service report shall be submitted to BNP authorities.
- 7) The contractor shall follow all safety and security rules while working in BNP premises.
- 8) The contractor shall be fully responsible for any accident if occurs to their personnel while doing work in BNP.
- 9) The payment shall be made for each service after successfully carried out and submitting inspection report along with bill.
- 7. The following two certificates are to be enclosed along with the quotation:
- a) That the prices offered are the best reduced rates and that the same service is not supplied at a lower rate to any other organization.
- b) That there is no agency commission involved.
- 8. Quantum of Liquidated damages:- If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, BNP DEWAS shall, without prejudice to other rights and remedies available to BNP DEWAS under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% (0.5%) percent (or any other percentage if prescribed in the SCC) of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% percent (or any other percentage if prescribed in the SCC) of the delayed goods' or services' contract price(s). During the above mentioned delayed period of supply and / or performance, the conditions incorporated under GCC sub-clause 23.4 shall also apply.
- 9. Security Deposit: If the value of purchase order exceeds Rs. 2.5 Lakh then the firm on whom purchase order will be placed will have to submit 10% of the total cost of the purchase order against security deposit in form of DD / FDR/ Bank Guarantee drawn on any scheduled commercial bank in India only in the favour of "The Chief General Manager, BNP Dewas" payable at Dewas within 21 Days from the date of contract. The Security Deposit should remain valid for a period of 60 days beyond the date of completion of all contractual obligations.
