- 2. **Non-disclosure undertaking:-** Participating bidder should submit non-disclosure undertaking for not sh aring the privacy of the organization (bidder of their personnel) to other firms/ person etc. by any mode of means.
- 3. **Payment Terms:-** The payment shall be made to the contractor through RTGS/NEFT are subject to dedu ction of tax(s), Cess liable by Government as per rules from time to time and will be made after the compl etion of every month or completion of assigned work on 10th day of each month and after certification by user department.
