8. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Participating bidder should submit unconditional acceptance of all the bid conditions including cope of work, payment terms etc.

2. **Non-disclosure undertaking:-** Participating bidder should submit non-disclosure undertaking for not sharing the privacy of the organization (bidder of their personnel) to other firms/ person etc. by any mode of means.

3. **Payment Terms:-** The payment shall be made to the contractor through RTGS/NEFT are subject to deduction of tax(s), Cess liable by Government as per rules from time to time and will be made after the completion of every month or completion of assigned work on 10th day of each month and after certification by user department. The bill must be submitted in triplicate after disbursement among the workers within 5 days. Further, the agency shall furnish a copy of deposition of monthly EPF/ESIC challan returns along with etc. with the bill falling which amount as deemed fit by bank Note Press, Dewas shall with hold in the next subsequent bill. The payment must be made before estate Custodian/Officer (HR) or GM BNP representative, which should be duly authorized by him.

4. **The bidder firm has to submit the documents as per the below eligibility criteria and the evaluation will be done considering the same:-**

a. **Experience and Past performance:** The bidder should have experience of having successfully supplied the manpower services in any one of the last five years ending on 31.03.2023

b. **Capability:** The bidder must have capability to provide the relevant services.

c. **Financial Standing:**

i. The Average Annual Turnover of the Bidder firm during last three years ending on 31st March 2023 should be more than Rs.24,37,192.00/

ii. The net worth of the bidder firm should:-

a) Not be negative on 31st March 2023

b) Not have eroded by more than 30% in the last three years, ending on 31st March 2023.

Note: MSEs and Start-ups are exempted from Eligibility Criteria 4(A) & 4(C). However, documents regarding 4(B) shall be verified.

5. **Liquidated Damages:** If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods or services contract price(s).

6. **GST Return:** Supplier should file the GST returns for outward supplies in time. In case of any input credit lost to BNP by way of their failure to file GST returns in time, BNP reserves the right to withhold the payment of further supplied till production of evidence of filing of returns.

7. **Note:-**

a) After accepting the contract additional SD must be deposited by firm whenever financial implication would be amended due to minimum wages revision for increment of working days (i.e. 365 days in place of 360 days) or increment of manpower strength etc.

b) Participating bidder needs to submit all related documents along with the bid.

- c) For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:-
- i. Purchase Order copy along with Tax Invoice(s) with self-certification by the bidder that at supplied against the invoices have been executed.
 - ii. Any other document in support of order execution like work completion certificate etc.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
