2. MSEs and Start-ups (registered for the tendered services) shall be exempted from eligibility criteria 4(a) and 4(c). However, its capacity and capability may be verified (if necessary) by the respective unit.

5. **Liquidated Damages:** If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum

mum deduction of the 10% of the delayed goods or services contract price(s).

6. **GST Return:** Supplier should file the GST returns for outward supplies in time. In case of any input credit lost to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplied till production of evidence of filling of returns.

- a) After accepting the contract additional SD must be deposited by firm whenever financial implication would be amended due to minimum wages revision for increment of working days (i.e. 365 days in place of 360 days) or increment of manpower strength etc.
- b) Participating bidder needs to submit all related documents along with the bid.
