Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. - 3. **LD Clause:** If the supplier fails to deliver any or all of the goods or fails to perform the services withi n the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and re medies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages , a sum equivalent to the ½ % percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deducti on of the 10 % of the delayed goods' or services' contract price(s).
