If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 4. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Scope of Supply

4. Certificates

At the time of submitting the offer, bidder has to submit the sealed and signed bid documen t as an acceptance of all additional terms and conditions, technical specification and payment t erms as mentioned in bid. The bidder firm should meet following eligibility criteria to qualify:

A. **Experience & Past Performance** : The Bidder should have manufactured and supplied **PO F Shrink Film 480 mm x 0.05 mm** at least **6400 Kgs** in any one of the last five years ending on 31st March 2024.

B. Capability, Equipment and Manufacturing facilities : The Bidder must have an annual capacity to manufacture & supply at least **6400 Kgs** of tendered item.

The bidder has to submit the following details along with the bid.

- (i) Name of the machine utilized to supply the quoted product.
- (ii) The number of machines being utilized for the production and the capacity of each m achine.
- (iii) Total annual capacity of manufacturer.
- (iv) Supply orders in hand and proportionate capacity to supply quoted amount.

C. Financial standing:

fered including all warranty obligations as per the general and special conditions of contract.

- 5. **For Authorized Representatives:** Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enfor ceable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligation s as per the general and special conditions of contract; and iii) the bidder himself should have been associa ted, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for s ame or similar 'Product' for past three years ending on 'The Relevant Date'.

 - 7. **Joint Ventures and Holding Companies:** Credentials of the partners of Joint v entures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goo ds/Equipment, and each partner must comply with all the PQC criteria independently. 9. Notes for Bidders:

- 12. **Capacity verification (if required)**: As part of technical evaluation, if required capacity verification of the bidders may be conducted by BNP. The offer of the firms not meeting the criteri a in verification as per bid document will be rejected.
- 13. "By participating in this tender, the suppliers/Vendors/Contractors are deemed to have underta ken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance."

3. In case of an unincorporated association or body of individuals, the beneficial owner is t he natural person(s), who, whether acting alone or together, or through one or more juridi cal person, has ownership of or entitlement to more than fifteen percent of the property o r capital or profits of such association or body of individuals;

4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.

5. In case of a trust, the identification of beneficial owner(s) shall include identification of t he author of the trust, the trustee, the beneficiaries with fifteen percent or more interest i n the trust and any other natural person exercising ultimate effective control over the trus t through a chain of control or ownership.

VI. An Agent is a person employed to do any act for another, or to represent another in de alings with third person.
