- I. **Power of Attorney/ Authorization** with the seal of company indicting that authorized signatory is competent and legally authorized to submit the tender and/or to enter into legally binding contract.
- II. **SCC-1: Performance Bond/ Security:** Within 21 days, the bidder has to submit Performance Bond/ Security equivalent to 5% of the order(s) value and valid for a period of 60 days beyond the completion of all contractual obligations including warranty period.

## **Scope of work:**

- 1. Collection, reception, Transportation and recycle / reuse of the Ink Sludge (Hazardous waste Category 35.3) Hazardous Wastes (Management, Handling and Transboundary Movement) Rules, 2016 sub rule 7 (1) and Hazardous and Other Waste (Management & Transboundary Movement) Rules, 2016 for the quantity of 200 MT.
- 2. All required packing material such as HDPE/LDPE bags for packing of Ink Sludge generated from BNP, labor, Vehicles, Tools and Tackles required for lifting and transportation of ink sludge will be arranged by contractor at his own cost.
- 3. ETP area near dewatering unit, sludge drying platform, filter beds and nearby drain chambers are to be cleaned regularly including replacement of sand and filter media. (Sand and filter medial will be provided by BNP, Dewas). Cleaning of Hazardous waste storage shed at ETP (Ink) including nearby area will be in the scope of vendor.

The contractor should submit undertaking that the waste ink sludge has been completely reprocessed/recycled/co-processed and no traces of waste ink sludge is lift untreated with the unit with each manifest. Also the acknowledgement about submitting manifest SPCB should be submitted to BNP on half yearly basis.
- 8. The Contractor must use authorized vehicle from MPPCB/CPCB for the transportation of ink sludge hazardous waste. The transport of the hazardous wastes shall be in accordance with the provision of these rules and the rules made by the Central Govt. under the Motor Vehicle Act 1988 and other guidelines issued from time to time in this regard with all required provisions of hazardous waste (M&H) Rule 2016.
- 9. The contractor shall comply with the instructions of manifest prepared and issued by BNP and no copy of the manifest should be misplaced for a period of 6 years w.e.f. date of issue. The firm shall submit the undertaking for the same.
- 10. The work done will be measured on weight basis of the ink sludge lifted designated location of BNP and the weighment will be done at BNP weighbridge. Weightment of authorized empty vehicle and loaded vehicle (used for transportation of ink sludge) will be done in presence of BNP representative (store and user section) and CISF representative. The difference of two weight i.e. weight of loaded vehicle minus weight of empty vehicle is considered as quantity lifted and payment will be made on this basis only.



11. All operations such as weightment, loading, transportation from BNP gates will be done in the presence of CISF personnel deployed by CRO.

### **Renewal / Termination of Contract:**

- i. This contract is entered for the disposal of quantity 200 MT.
- ii. This contract will remain effective and in operation only until the authorization issued by MPPCB to contractor is valid, any change/revision/amendment made in either of the authorization will become applicable with immediate effect.
- iii. Bank Note Press, Dewas reserve the right to terminate the contract by giving one month prior notice without assigning any reason.
- iv. The contract is initially for a period of four (04) month.
