SIT 1: Eligible Goods: All goods to be supplied under the contract shall have their origin in India or Indian Agent in case of imported item, subject to any restriction imposed in this regard in Section III (SIT). The term "origin" used in this clause means the place where the goods are mined, grown, produced, or manufactured or from where the related services are arranged and supplied.



SCC-8: Quantum of Liquidated damages: If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

SCC-9: Resolution of disputes:

If dispute or difference of any kind shall arise between BNP DEWAS and the supplier in connection with or relating to the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within twenty one days of its occurrence, then, unless otherwise provided in the SCC, either BNP DEWAS or the supplier may seek recourse to settlement of disputes through arbitration as per The Arbitration and conciliation Act 1996 as per following clause.

SCC-10: Arbitration Clause: All disputes & differences arising out of or in any way touching or concerning this agreement (except those for which specific provision has been made therein) shall be referred to Sole Arbitrator to be appointed by CMD, SPMCIL. This contract has to be interpreted in accordance with the laws of the Union of India and arbitration proceedings shall be conducted in India under the Arbitration and conciliation Act 1996. The Arbitrator so appointed shall be an SPMCIL Officer who had not dealt with matters to which this agreement relates and in course of his duties had not expressed views on all or any of the matter in dispute or differences. The Award of the Sole Arbitrator shall be final and binding on the parties.

#### SCC-11: Failure & Termination

A) Cancellation of contract for Default: Without prejudice to any other remedy for breach of contract, like removal from the list of registered supplier, by written notice of default sent to the supplier, the contract may be terminated in whole or in part:

(i) If the supplier fails to provide any or all the goods within the time period (s) specified in the contract,

or any extension thereof granted

(ii) If the supplier fails to perform any other obligation under the contract within the period (s) specified in the contract or any extension thereof granted.



B) Termination of Contract for convenience: Bank Note Press, Dewas (M.P.) may at any time terminate the Contract by giving you one month's prior notice in writing to that effect and shall have the liberty to appoint any other agency to carry out your obligations under this Contract.

## SCC-12: Force Majeure:

12.1 In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.

- 12.2 Notwithstanding the provisions contained in GCC clauses 23, 24 and 26, the supplier shall not be liable for imposition of any such sanction so long the delay and/ or failure of the supplier in fulfilling its obligations under the contract is the result of an event of Force Majeure.
- 12.3 In case due to a Force Majeure event is unable to fulfill its contractual commitment and responsibility, BNP Dewas will notify the supplier accordingly and subsequent actions taken on similar lines described in above sub-paragraphs.

## SECTION VIII: QUALITY CONTROL REQUIREMENTS

(As per technical specification mentioned in section VII)

1. The bidder should assure that the material offered by them against this tender should have the technical parameters strictly as per the technical speciation mentioned in Section VII (Technical speciation). If any deviations observed then the bidder have to specify clearly in their techno-commercial bid.

## 2. FAT: (Final Acceptance Test) and FAC (Final Acceptance certificate):

## (a) FAT: (Final Acceptance Test)

The FAT will continue for a month for both kettles & allied systems. Minimum 10 batches of varnish of different batch size will be made in 2KL capacity kettle & minimum 5 batches will be made in 180 L Pilot scale kettle. All the equipment of varnish cooking plant should work properly as per requirement during manufacturing of varnish batches. All the spares required till completion of FAT is to be provided by the firm.

## (b) FAC: (Final Acceptance Certificate):

Upon satisfactory completion of FAT, BNP shall issue FAC (Final Acceptance certificate) for the system.





#### SECTION IX: ELIGIBILITY CRITERIA

# Design, Supply, Installation & Commissioning of New Varnish Cooking Plant on Turnkey Basis

## The bidder firm should meet following Eligibility Criteria to qualify:

- (a) Experience & Past Performance:- The bidder (manufacturer or principal of authorized representative hereinafter referred simply as 'The Bidder') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned New Varnish Cooking Plant on Turnkey Basis with the same or higher specifications of at least one number in last five years ending on "31.03.2024". At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.
- (b) Capability- Equipment & manufacturing Facilities:- The bidder must have an annual capacity to manufacture and supply at least 01 similar New Varnish Cooking Plant on Turnkey Basis. Note: At the discretion of the purchaser, the capacity & capability assessment/ verification of bidder/manufacturer firms shall be undertaken by technical committee or through a third party technical consultancy/inspection agencies to ensure that firms are identified and capable to develop the item as required.

## (c) Financial Standing:-

- (1) The average annual financial turnover of the bidder firm (manufacturer or principal of authorized dealer) during the last three years, ending on '31.03.2024' should be at Rs.5,41,60,000/- or equivalent in foreign currency at exchange rate prevailing on 31.03.2024 as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.
- (2) The net worth of the firm should
  - a. not be negative on '31.03.2024' and
  - b. not have eroded by more than 30% in the last three years, ending on '31.03.2024

#### Note

- 1. To ascertain criteria net worth of initial and last financial year shall be compared.
- 2. To ascertain financial standing criteria, bidders must submit seal & signed Balance Sheet & Profit and loss statement of last 3 financial year i.e. FY 2021-22, FY2022-23 & FY 2023-24, duly certified by Chartered Accountants/ Cost Accountants in India or equivalent in relevant countries.
- 3. For MSEs and Start-ups (registered for the tendered item) all financial criteria & Experience and past performance criteria shall be exempted. However, its capacity and capability may be verified (if necessary) by the respective unit as per the standard format attached in Annexure—III.
- (c) Applicability to 'Make in India': Bidders (manufacturer or principal of authorized representative) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided:
  - i) Their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and
  - ii) The Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content.



- (ii) The bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply, Installation and Commissioning and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.
- (d) For Authorized Representatives: Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided:
  - i) Their principal manufacturer meets all the criteria above without exemption, and
  - ii) The principal manufacturer furnishes a legally enforceable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and
  - iii) The bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid Supply, Installation and Commissioning for same or similar 'Product' for past three years ending on 'The Relevant Date'.
- (e) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorized re presentative) who is a successful past supplier of Design, Supply, Installation & Commissioning of New Varnish Cooking Plant on Turnkey Basis. in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL.
- (f) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- (g) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Start-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.



## **Technical Specifications of New Varnish Plant**

Technical Specification for Plant Layout, Design, Installation & Commissioning Cooking Plant.

#### Introduction:-

Bank Note Press, Dewas (Madhya Pradesh) is an industrial unit of Security Printing and Minting Corporation of India Limited (SPMCIL) which is wholly owned by Ministry of Finance, Government of India. Bank Note Press (BNP) Dewas was established in 1974 to print world class high quality bank notes/ currency notes of different denominations.

BNP Dewas has its own Ink Factory for manufacturing of security printing inks.

Ink Factory manufactures variety of varnishes comprising of oils, solvents, resins etc. The maximum temperature of the varnish may go upto 280°C. We intend to get installed modern varnish cooking plant of 2KL net volume & Pilot scale kettle of 180 L net volume. Specific gravity of varnish is 0.8 to 1. Net volume of kettles should be 75% of gross volume. Both the kettles should be capable of making half of the net volume capacity varnish batches.

#### 1.0 General:-

- 1.1 The bidder firm shall visit BNP Dewas to see the existing space available for installation of the plant before submitting the bid. The firm has to fix the locations of processing unit, machineries, equipment, heating & cooling system, cooling tower, control room, filtration unit, weighing balances, safety arrangements, man & material movement flow etc. Final plant layout is to be mutually agreed by BNP & the firm. Lay out of the plant to be done as per standard industrial practices considering all safety norms in compliance to Factory Act, 1948 requirements as well as all legal compliances as per State/Central Government. Various aspects like Plant safety, optimum utilization of man, machine & method, minimum material movement, energy efficiency, minimum waste generation with ECO friendly concept etc. are to be considered on priority while making the plant layout & design.
- 1.2. Civil work: BNP will take up the civil related work in coordination with the successful bidder. All the metal structures required for the installation of plant and machineries to be provided by the firm. Small civil work required for installation & commissioning of the plants to be carried out by the firm.
- 1.3. All safety norms to be guaranteed in regards to plant, structures & equipment in the project. The bidder should submit the certificates to this effect issued by the competent certifying agencies of Government of India/State Government.
- 1.4. All reactors, vessels to be radio-graphically tested as per ASME section VIII div. 1 and the test to be carried out and certified by BARC approved third party.
- 1.5 Testing of pipelines, condensers & heat exchangers should conform to TEMA code. A certificate from the competent certifying agency to be submitted by the bidder.





- 1.6 All the design of vessel and heat exchanger should conform to ASME section VIII div. 1/IS 2825 unfired pressure vessel.
- 1.7 All the pipelines in heat exchanger and condenser should be seamless.
- 1.8 Stability certificate from Government approved agencies for structure to be provided in the prescribed form.
- 1.9 The proposed plant is of steel structure hence all precautions to be taken for laying electrical cables and equipment to avoid all kinds of electrical hazards. Electrical safety certificate, obtained from Government approved agency, to be submitted.
- 1.10 The plant to be integrated with the electric thermic oil heating system.
- 1.11 Standby pump for every pumping operation to be provided.
- 1.12 All the pumps should be Kirloskar/Chem-flow/ Cadillac or equivalent make. Gear pumps have stainless steel contact parts.
- 1.13 All the electrical motors should be energy efficient (minimum IE2 series) and Kirloskar/Crompton/Bharat Bijlee or equivalent make. All electrical motors in processing plant should be flame proof and water proof.
- 1.14 All gear boxes should be of BONFIGLIOLI/ POWER BUILD or equivalent make.
- 1.15 Lightning arrestor and proper earthing to avoid static charges to be provided wherever necessary as per standard codes.
- 1.16 The firm has to demonstrate the operation of each component of the plant during making of various varnishes.
- 1.17 The firm has to provide in three sets, the Standard Operating Procedures and Operating Manual with Check list for plant operations, do's & don'ts for operation, troubleshooting operations, plant maintenance including electrical, mechanical drawings, P&ID diagram and literature, network layouts for computerization etc.
- 1.18 All the pipelines & structures to be painted as per standards industrial norms. Direction of flow to be indicated with arrows on pipelines.
- 1.19 The firm has to carry out HAZOP study for the varnish plant.

## 2.0 Varnish Cooking Kettle (Main Plant)

2.1 Capacity – 2 KL net volume. (Sp. Gravity of varnish 0.8 to 1, net volume is 75 % of gross volume & kettle should be capable of making small size varnish batches of 1KL)

The material of construction of kettle should be SS 316L, non-corrosive, non-rusting with certificate of conformity. The thickness of the kettle wall should be 8 mm thick SS 316L plate. The heating of the kettle to be made with suitable thermic oil through surrounding LIMPET coils of appropriate design.

The kettle must withstand the pressure of 2kg/cm<sup>2</sup> and hydro test of 5kg/cm<sup>2</sup> and full vacuum. Test certificate to be provided, failing which the kettle will not be accepted. Appropriate testing of LIMPET coil to be done and test certificate to be provided for the same.

- 2.2 Agitator: Suitable agitator with variable speed for effective mixing of the content inside the kettle should be provided. Self-lubricating shaft sealing with proper cooling mechanism. Mechanical Seal should be leak proof made of highest grade material with all safety arrangement. MOC of shaft should be SS 316L
  - Diameter of shaft: Shaft with suitable diameter for sustaining the mixing load with double mechanical seal of reputed make and with cooling pad.
- 2.3 Drive Arrangement: Suitable latest drive mechanism with flame-proof electrical motor with safety arrangement. The Variable Frequency Drive (VFD) controlled motor to be installed for controlling the rpm of agitator. The rpm should be adjustable in 10 to 60 rpm range. The operating speed is 10 rpm and 60 rpm as per need. There should be vibration free drive arrangement with minimum noise level. Drive arrangement should be belt driven. The capacity of motor required for agitation should be of minimum 10 HP having sufficient power to mix solid & semi-solid resins during varnish manufacturing.

Suitable capacity of flame-proof electrical motor should be provided.

All the electrical motors should be energy efficient.

Gear box should be of BONFIGLIOLI / POWER BUILD or equivalent make.

- 2.4 Main charging holes and nozzles: Manhole with proportionate size with easily removable lid with gasket. Other nozzles: - Light glass, sight glass (with lights), Safety valves, liquid material charging nozzles for automatic/manual charging of liquid raw materials, nitrogen purging line, Additional nozzles for future need etc.
- 2.5 Spring loaded safety valve to be provided.
- 2.6 Thermo-well: Thermo-wells to be provided at suitable points for measuring temperatures of kettle & thermic oils at various points with PT100 (RTD) or equivalent.
- 2.7 Bottom Outlet: -Y-type valve of suitable size at bottom outlet to be provided for discharging of varnish.
- 2.8 Sampling point: sampling point to be provided in the lower portion of shell.
- 2.9 Temperature and pressure gauges to be provided at the top of the kettle.
- 2.10 Suitable capacity condenser for the main kettle to be provided. MoC should be SS 316L.
- 2.10 Insulating material & aluminum cladding should be as per standard industrial norms so that heat losses can be minimized from kettle, equipment, pipelines, heaters etc.
- 2.11 Any other item not described above but part of the standard state of the art equipment shall be provided.
- 2.12 Plant operations should be operator friendly.
- 2.13 Kettle should be on load cell with indicator & should be calibrated.







## 3.0 Digital weighing scales

01 no. of heavy duty digital weighing balance capacity 1 MT at ground floor to be provided for weighing of raw material like solvent, oil, resin etc. (least count – 0.1 to 0.2 kg)

01 nos. of heavy duty digital weighing scale of 1MT to be provided for weighing of varnish filled drums at the time of manual discharging of varnish from kettle. (least count – 0.1 to 0.2 kg). Digital weighing scales should be of reputed make like AVERY, METLER TOLEDO, ESSAE OR EQUIVALENT having service facilities available in Dewas/Indore/Ujjain/Bhopal. Both the weighing scales should be flame proof.

## 4.0 Heating System and Cooling System

- 4.1 The electric heating system suitable for heating thermic fluid up to 300°C. The capacity of heater should be 4,00,000 Kcal/hr. The ramping rate of the heating should be greater than or equal to 1.7 °C/min which should be controllable.
- 4.2 Interlocks, sensors, differential pressure switches, Non-Return Valves, bellows for pipeline, hooters/sirens/alarms for abnormal process parameters, temperature setting arrangement etc. to be provided with the heater. Certificate of the Electrical Heater conforming to safety norms, legal compliances & international/national standard industrial norms to be provided along with operating manual of heater.

## 4.3 Scrubbing System:

Appropriate vapour scrubbing/collection system should be provided. The design of scrubbing system should be such that vapour of varnish while processing inside the kettle should not come outside the manhole while charging of material.

- 4.4 Heat exchanger for cooling of thermic oil to be provided. The ramping rate of the cooling should be greater than or equal to 0.7 °C/min which should be controllable.
- 4.5 Suitable capacity cooling towers to be provided.
- 4.6 New Thermic fluid of reputed make like HYTHERM 600/Marlotherm-S/ Therminol-66 or exactly equivalent compatible for Electric heater with complete filling of the system to be provided with the plant with four extra drums of 200-210 lit each. Test certificate, MSDS etc. to be provided along with the thermic fluid.
- 4.7 Suitable size expansion tank/ de-aerator tank to be provided with all safety arrangement and as per standard industrial norms complying with legal requirements. Level indicator to be provided on expansion tanks. Design of expansion tank should be such that there should not be any oil spillage from the expansion tank. Suitable metal structure for placing of expansion tank to be provided. Expansion tank should be placed at appropriate height as per standard industrial norms.
- 4.8 The supplier should provide the compressors as per the requirement of the varnish cooking plant.



#### 5.0 Filtration:-

Filtration system should be effective, easy to operate, high filtration rate, easy to maintain & clean, having lower operational cost etc. Online filtration system to get the filtrated varnish through minimum 50 micron size filter. Stage wise filtration system should be there like 500 micron, 200 micron, 100 micron & 50 micron for discharging of varnish. Suitable cápacity flame proof gear pump set to be provided to transfer whole varnish batch within 1-2 hrs from kettle to 200 lit drums/storage tanks.

Provision for drum filling directly from the cooking kettle with & without filtration system to be made.

Filtration assembly should be made up of corrosion free material with pumping facility if needed.

There should be option for discharging varnish from kettle to open mouth 200 lit drums (Manual transfer of varnish) & for discharging varnish from kettle to storage tanks (In-line transfer of varnish).

Before starting actual discharge of varnish into drums/storage tanks there should be provision for circulation of varnish. (kettle – filtration system – kettle).

## 6.0 Storage tanks

- 6.1 Two storage tanks of 6 KL capacity (net volume) & two storage tanks of 4 KL capacity (net volume) to be provided for storage of varnishes. ALL THE TANKS SHOULD BE PROVIDED WITH LEVEL INDICATORS. Suitable heating system to be provided to maintain the varnish temperature of 80 ± 5°C inside the tanks. Temperature, pressure and level indicators to be provided on varnish storage tanks. A suitable dip stick with markings are to be provided for each tank to cross check the varnish level from the top. All tanks are suitably calibrated by an authorized agency and the chart to be prepared for the same. Level switches, sensors, hooters etc. to be provided.
- 6.2 Suitable pumping and pipeline arrangement should be provided.
- 6.3 Ladder should be provided on each tank as per safety standards.
- 6.4 All standard nozzles/accessories to be provided.
- 6.5 All the storage tanks should be designed as per standard national/international industrial norms.
- 6.6 Varnish storage tanks in weighing section of ink factory—4 numbers of 2 KL capacity (net volume) are to be installed at the weighing section of new Ink Factory building. Suitable heating system to be provided to maintain the varnish temperature of  $80 \pm 5^{\circ}$ C inside the tanks. Temperature and level indicators to be provided on varnish storage tanks in weighing section. All the pipelines from varnish kettle to storage tanks should be heat traced if needed and insulated. Suitable pumping arrangement to be provided.
- 6.7 Thermic oil charging and draining facility:-

Storage tanks for charging & draining of thermic oil with appropriate size to be provided as per the volume of thermic oil inside the system, however both the tanks should not be less than 1KL capacity each. Suitable pumping arrangements to be provided.





## 7.0 Piping, Pumps and Motors

- 7.1 All pipelines with appropriate dimension are to be supplied. All hot pipelines need to be insulated properly.
- 7.2 All pumps and motors are to be FLAME PROOF in processing area.
- 7.3 All the electrical motors should be of Kirloskar/ Crompton/ABB/Siemens or equivalent make.
- 7.4 Firm has to demonstrate the complete transfer of varnish with no left out in pipeline with suitable capacity gear pumps and back-up compressed air/nitrogen.
- 7.5 Suitable air/nitrogen flushing & purging facility to be provided.
- 7.6 Arrangement of pumps & design of pipelines for varnish discharge system should be such that varnish can be transferred from kettle through filtration system directly into 200 lit barrels or storage tanks near kettle (6KL 2 nos. & 4 KL- 2 nos) or storage tanks in weighing section (4KL 2 nos.)

## 8.0 Hoist with secure cage 1 MT capacity & Electrical heating oven:-

Hoist with secure cage 1 MT capacity of reputed make should be provided with all safety certifications & guarantee/warrantee for at least 1 year. The manufacturer of the hoist should have its service centre at places nearby Dewas like Indore/Bhopal/Ujjain etc.

The firm has to provide Electrical heating ovens 03 nos. (for accommodating 02 drums of 200 lit capacity in each oven). Proper insulation should be provided for melting of high viscous alkyd resins. The maximum temperature required is  $100^{\circ}$ C with  $\pm$  2°C accuracy and having digital pre-setting at any temperature from  $30^{\circ}$ - $100^{\circ}$ C also temperature indicating facility should be provided.

For uniformity, hot air circulation facility should be provided.

The bottom area of the oven should be having strong horizontal pipes so as to facilitate sliding of alkyd filled drums for keeping the drums vertically inside the oven. A suitable ramp should also be provided for pushing the drums inside the oven from ground floor.

Necessary interlocks, sensors are to be provided for overheating or any other malfunctioning of the oven. Highest safety arrangement to be provided.

## 9.0 Electrical and Illumination

- 9.1 All electrical fittings and equipment to be used should be fire/flame proof in processing area.
- 9.2 APFC panel is to incorporated for power factor correction.
- 9.3 All the electrical cables should be fire/flame retardant. Make Havells/Finolex/RR cables/L&T or equivalent. Armoured cables to be provided.
- 9.4 Each motor should be provided with push button station near the motor and to be provided with speed regulator. Electrical cabling should be as per standard industrial norms considering highest safety.
- 9.5 The power supply will be made available by BNP at one source in building:

3 phase, 415 V  $\pm$ 

10%,  $50 \text{ Hz} \pm 3\%$ .



- 9.6 The electrical system should be IEEE 513 complied. Active Harmonic filter is to be incorporated of suitable capacity as per load requirement.
- 9.7 All the electrical safety compliances need to be followed as per IER 1956 up to date for similar/same plants.
- 9.8 Illumination above the new varnish cooking plant should be energy efficient LED type in flame/fire-proof fittings.
- 9.9 MCC/PLC panel should have rated switchgear to switch on-off the system.

## 10.0 Instrumentation, Controls & Automation

- 10.1 Online temperature monitoring, recording and printing facility should be provided in control system. Provision for temperature records should be connected to computer at control room to directly check the temperature.
- 10.2 Suitable controlling system consists of Programmable Logic Controller (PLC)/SCADA or equivalent control system of reputed make should be provided.
- 10.3 Controlling system should be suitable for Auto and Manual mode of operation.

## 11.0 Electrically heated Pilot Kettle/Reactor

One pilot kettle of 180 KL capacity (net volume) with suitable heating & cooling system for producing pilot varnish batches to be provided with all standard accessories. Pilot kettle to be designed as per international/national standard industrial practices and considering highest safety norms. The pilot reactor should be operator friendly. MOC-SA 240 SS 316. The process requirement is same as per main kettle of 2 KL. Platform/structure for pilot kettle to be provided.

## 12. Training & Final Acceptance Test (FAT)

The firm has to give the training to BNP staff and operators on complete operations of varnish cooking plant, heating & cooling system, filtration system, finished varnishes and overall plant under contract.

The FAT will continue for a month for both kettles & allied systems. Minimum 10 batches of varnish of different batch size will be made in 2KL capacity kettle & minimum 5 batches will be made in 180 L Pilot scale kettle. All the equipment of varnish cooking plant should work properly as per requirement during manufacturing of varnish batches. All the spares required till completion of FAT is to be provided by the firm.

#### 13.0 Miscellaneous

- 13.1 Any item not covered in this document but essential technical requirement for installation and commissioning of the plant is to be supplied as a part of contract.
- 13.2 Any advance technology/equipment which can enhance the productivity, quality of varnish & safety will also be considered. The firm has to carry-out the formal risk-assessment/ HAZOP study of the Varnish Cooking Plant.
- 13.3 Chief General Manager, BNP Dewas reserves the right to alter the provisions of the contract based on the instant need during installation of the plant with mutual consent with the vendor.



13.4 The firm has to give details of the spares, instruments, consumables, lubricants etc. along with their specification as a part of the Instruction Manual for the plant.

## **WARRANTY:**

The bidder firm shall provide for ONE YEAR warrantee for complete plant.



- 1. Capacity Verification Team will initiate the capacity verification/assessment of the firms for the relevant item(s)/equipment(s)/product(s) as per Capacity and Capability Assessment Form mentioned below and submit their recommendations/report to the Tender Evaluation Committee (TEC).
