- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

2. At the time of submitting the offer, bidder has to submit the sealed and signed bid d ocument as an acceptance of all additional terms and conditions, technical specification and payment terms as mentioned in bid.

- 3. The bidder firm should meet following eligibility criteria to qualify:
 - A. **Experience & Past Performance**: The Bidder should have manufactured and supplied **Caustic Soda Flakes** at least **40 MT** in any one of the last five years ending on 31s t March 2024.
 - **B. Capability, Equipment and Manufacturing facilities**: The Bidder must have an annual capacity to manufacture & supply at least **40 MT** of tendered item.

The bidder has to submit the following details along with the bid.

- (i) Name of the machine utilized to supply the quoted product.
- (ii) The number of machines being utilized for the production and the capacity of each machine.
- (iii) Total annual capacity of manufacturer.
- (iv) Supply orders in hand and proportionate capacity to supply quoted amount.

C. Financial standing:

- (i) The average annual financial turnover of the bidder during the last three financial years ending on 31st March 2024 should be at least **Rs. 19,68,000/-** as per the annual report of the relevant period, duly authenticated by a charted accountant/cost accountant in India.
- (ii) The net worth of the bidder firm should:
 - (a) Not be negative on 31st March 2024
 - (b) Not have eroded by more than 30 % in the last three years, ending on 31st Ma rch 2024.

Note:

- 1. Participating bidder needs to submit all related documents along with the bid.
- 2. For MSEs and Startups (registered for the tendered item) all financial criteria shall be exempted. However, its capacity and capability may be verified (if necessary).
- 3. All the discretion of the purchaser, the capacity & capability assessment/ verificat ion of bidder/manufacturer firms shall be undertaken by technical committee or thr ough a third party technical consultancy/ inspection agencies to ensure that firms a re identified and capable to develop the item as required.
- 4. **Applicability to 'Make in India'**: Bidders (manufacturer or principal of authorized repr esentative) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate docume ntary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. Iii) the

bidder (manufacturer or principal of authorized representative) furnishes along with the bid a lega lly enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfact ory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Pro duct' offered including all warranty obligations as per the general and special conditions of contract.

- 5. **For Authorized Representatives:** Bids of bidders quoting as authorized representati ve of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorization in the prescribed form assuring full guar antee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 'The Relevant Date'.
- 6. **For Existing successful Past Suppliers:** In case the bidder (manufacturer or princ ipal of authorized representative) who is a successful past supplier of **Caustic Soda Flakes** in a t least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do n ot meet any or more of requirements above, would also be considered to be qualified in view of t heir proven credentials, for the maximum quantity supplied by him in such recent past to any un its of SPMCIL.
- 7. **Joint Ventures and Holding Companies:** Credentials of the partners of Joint venture s cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Eq uipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- 8. **Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Start-up enterprises as recognized by Department for Promotion of Industry and Internal Tra de (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups may be either MSE or otherwise.

9. **Notes for Bidders:**

- (i) Along with all the necessary documents/ certificates required as per the tende r conditions, the bidder should furnish a brief write-up, backed with adequate dat a, explaining his available capacity (both technical and financial), for manufactur e and supply of the required goods/ equipment, within the specified time of com pletion, after meeting all their current commitments.
- (ii) Supporting documents submitted by the bidder must be certified as follows:
- (iii) All copy of supply/ work order; respective completion certificate and contact de tails of clients; documents issued by the relevant industries department; National Small Industries Corporation (NSIC); manufacturing licence, annual report, etc., in support of experience, past performance and capacity/ capability should be aut

- henticated by the by the person authorized to sign the tender on behalf of the bidder.
- (iv) All financial standing data should be certified by certified accountants, for exa mple, Charted Accountants/ Cost Accountants in India and equivalent in relevant countries; and
- (v) Indian bidder or Indian counterparts of foreign bidders should furnish their Per manent Account Number.
- 10. **LD Clause:** If the supplier fails to deliver any or all of the goods or fails to perform t he services within the time frame(s) incorporated in the contract, SPMCIL shall, without pr ejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof u ntil actual delivery or performance, subject to a maximum deduction of the 10% of the de layed goods' or services' contract price(s).
- 11. "**GST Return**: Supplier should file the GST returns for outward supplies in time. In case of any Input credit Loss to BNP by way of their failure to files GST returns in time, BNP res erves the right to withhold the payment of further supplies till production of evidence of fil ling of returns."
- 12. **Capacity verification (if required)**: As part of technical evaluation, if required capacity verification of the bidders may be conducted by BNP. The offer of the firms not meeting the criteria in verification as per bid document will be rejected.
- 13. "By participating in this tender, the suppliers/Vendors/Contractors are deemed to have und ertaken that they shall not give or take, any financial or non-financial bribe, to or from any one during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance."
- 14. **Delivery Schedule:** Firm have to supply the material i.e. Caustic Soda Flakes for 100 MT as per below :
- 1. Successful firm have to supply 1^{st} installment of 25 MT within the 30 days from the date of is sue of GeM contract.
- 2. 2nd installment of 25 MT on within 30 to 60 days.
- 3. 3rd installment of 25 MT on within 60 to 90 days.
- 4. 4th installment of 25 MT on within 90 to 120 days.
- 15. Ministry of Finance, Department of Expenditure, Public Procurement Division, Order s (Public Procurement 1, 2 and 3) F.No.6/18/2019-PPD dated 23rd/ 24th July 2020 (or a ny further amendments thereof) regarding eligibility of bidders from specified countrie s shall be applicable to this tender. Salient features of this are:

I. - 1. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five p er cent. of shares or capital or profits of the company.
- 2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting

alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership.

- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natur al person(s), who, whether acting alone or together, or through one or more juridical person, has o wnership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the re levant natural person who holds the position of senior managing official.
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the auth or of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and a ny other natural person exercising ultimate effective control over the trust through a chain of cont rol or ownership.
- VI. An Agent is a person employed to do any act for another, or to represent another in dealings wi th third person.
