1. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

2. At the time of submitting the offer, bidder has to submit the following:

- a) Sealed and Signed Technical Specification .
- b) Sealed and signed bid document as an acceptance of all terms and conditions mentioned in the bid with out any deviation.
- c) Undertaking/Declaration certificate that you are currently not suspended/Banned/Blacklisted by any mi nistry/department of govt. of India or by any state govt. for business dealing.
- d) The bidder has to submit undertaking that the operation of the company in Pakistan/China, should be suit ably firewalled from the contract/operations in India and no employee who has previously worked or has b een posted in Pakistan/China, or is a Pakistani/Chinese national or is a person of Pakistani/Chinese origin s hould be engaged by the company for this project.

"Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any p erson or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the description s of bidders stated hereinbefore, including any agency branch or office controlled by such person, particip ating in a procurement process.

"Bidder from a country which shares a land border with India" for the purpose of this Order means: -

(a) An entity incorporated, established, or registered in such a country; or

(b) A subsidiary of an entity incorporated, established, or registered in such a country; or

(c) An entity substantially controlled through entities incorporated, established, or registered in such a country; or

(d) An entity whose beneficial owner is situated in such a country; or

(e) An Indian (or other) agent of such an entity; or

(f) A natural person who is a citizen of such a country; or

(g) A consortium or joint venture where any member of the consortium or joint venture falls under any of t he above

The beneficial owner for the purpose of (g) above will be as under:

(a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s). Who , whether acting alone or together, or through one or more juridical person, has a controlling ownership int erest or who exercises control through other means.

(b) Explanation-

- 1. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per ce nt. of shares or capital or profits of the company.
- 2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifte en percent of capital or profits of the partnership.
- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural p erson(s), who, whether acting alone or together, or through one or more juridical person, has owner ship of or entitlement to more than fifteen percent of the property or capital or profits of such associ ation or body of individuals;
- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the releva nt natural person who holds the position of senior managing official.
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any oth er natural person exercising ultimate effective control over the trust through a chain of control or o wnership.

An Agent is a person employed to do any act for another, or to represent another in dealings with third person.

By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that the y shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during t he execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.

3. Delivery The firm have to deliver the material within 30 days from the date of issue of Ge m Contract.

5. Liquidated Damages:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SP MCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½ % percent of the delivered price of the delayed goods and/ or services for each week of delay or part there of until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

6. GST Return:

Supplier should file the GST returns for outward supplies in time. In case of any Input credit Loss to BNP by

way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further s upplies till production of evidence of filling of returns."
