- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 3. **LD Clause**: If the supplier fails to deliver any or all of the goods or fails to perform the services with

in the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights an d remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated d amages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or s ervices for each week of delay or part thereof until actual delivery or performance e, subject to a maximum deduction of the 10% of the delayed goods' or service s' contract price(s).

- 4. GST Return: Supplier should file the GST returns for outward supplies in time. In case of any Inp ut credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."
- 5. Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1, 2 and 3) F.No.6/18/2019- PPD dated 23rd/ 24th July 2020 (or any further amendments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. Salient features of this are:
- I. Any bidder from a country which shares a land border with India (excluding countries as listed on the website of Ministry of External Affairs, to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects) will be eligible to bid in this tender only if the bidder is registered with the Registration Committee constituted by the Department for Promotion of Industry and Internal Trade (DPIIT). The bidders shall enclose following certificate in this regard:

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; and solemnly certify that we are not from such a country or, if from such a country, we are registered with the Competent Authority (copy enclosed). We hereby cer

tify that we fulfill all requirements in this regard and are eligible to be considered."

**II.** In tenders for Turnkey contracts including Works contracts, the successful bidder shall not be a llowed to sub-contract works to any contract or from a country which shares a land border with Ind ia unless such con tractor is similarly registered with the Registration Committee constituted by the Department for Promotion of Industry and Internal Trade (DPII T). In such cases the bidders shall enclose following certificate:

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India and on sub-contracting to contractors from such countries,; and so lemnly certify that we are not from such a country or, if from such a country, we are registered wi th the Competent Authority (copy enclosed) and we will not subcontract any work to a contractor from such countries unless such contractor is registered with the Competent Authority. We hereby certify that we fulfill all requirements in this regard and are eligible to be considered."

III. "Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.

IV. "Bidder from a country which shares a land border with India" for the purpose of this Order me ans:- (a) An entity incorporated, established, or registered in such a country; or

- (b) A subsidiary of an entity incorporated, established, or registered in such a country; or
- (c) An entity substantially controlled through entities incorporated, established, or registered in su ch a country; or
- (d) An entity whose beneficial owner is situated in such a country; or
- (e) An Indian (or other) agent of such an entity; or
- (f) A natural person who is a citizen of such a country; or
- (g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above

V. The beneficial owner for the purpose of (III) above will be as under: (a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s). Who, whether acting al one or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.

#### (b) Explanation

- **1**. "Controlling ownership interest" means ownership of or entitlement t o more than twenty-five p er cent. of shares or capital or profits of the company.
- 2. In case of a partnership firm, the beneficial owner is the naturalness on(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership.
- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profit s of such association or body of individuals;
- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the r elevant natural person who holds the position of senior managing official.
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the auth or of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and a

ny other natural person exercising ultimate effective control over the trust through a chain of cont rol or ownership.

- VI. An Agent is a person employed to do any act for another, or to represent another in dealings wi th third person.
- 6. **Anti Bribery Clause**: By participating in this tender, the suppliers/Vendor s/Contractors are de emed to have undertaken that they shall not give or take, any financial or non-financial bribe, to o r from anyone during the tender or during the execution of the contract thereafter and if they noti ce any such incident happening, they shall report it to Vigilance

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
