- 1. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. - 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

- 4. LD Clause: If the supplier fails to deliver any or all of the goods or fails to perform the services with

in the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and re medies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a s um equivalent to the $\frac{1}{2}$ % percent of the delivered price of the delayed goods and/ or services for each wee k of delay or part thereof until actual delivery or performance e, subject to a maximum deduction of the 10 % of the delayed goods' or service s' contract price(s).

5. **GST Return**: Supplier should file the GST returns for outward supplies in time. In case of any Input

credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."

- 6. Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1, 2 and 3) F.No.6/18/2019- PPD dated 23rd/ 24th July 2020 (or any further ame ndments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. Salient features of this are:
- I. Any bidder from a country which shares a land border with India (excluding countries as listed on the we bsite of Ministry of External Affairs, to which the Government of India has extended lines of credit or in whi ch the Government of India is engaged in development projects) will be eligible to bid in this tender only if the bidder is registered with the Registration Committee constituted by the Department for Promotion of In dustry and Internal Trade (DPIIT). The bidders shall enclose following certificate in this regard:

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; and solemnly certify that we are not from such a country or, if from such a country, we are registered with the Competent Authority (copy enclosed). II. In tenders for Turnkey contracts including Works contracts, the successful bidder shall not be allowed to sub-contract works to any contract or from a country which shares a land border with India unless such contractor is similarly registered with the Registration Committee constituted by the Department for Promo tion of Industry and Internal Trade (DPII T). In such cases the bidders shall enclose following certificate:

III. "Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means an y person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descripti ons of bidders stated hereinbefore, including any agency branch or office controlled by such person, partic ipating in a procurement process.

IV. "Bidder from a country which shares a land border with India" for the purpose of this Order means:- (a) An entity incorporated, established, or registered in such a country; or

- (b) A subsidiary of an entity incorporated, established, or registered in such a country; or
- (c) An entity substantially controlled through entities incorporated, established, or registered in such a country; or
- (d) An entity whose beneficial owner is situated in such a country; or
- (e) An Indian (or other) agent of such an entity; or
- (f) A natural person who is a citizen of such a country; or
- (g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above

V. The beneficial owner for the purpose of (III) above will be as under: (a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s). Who, whether acting alone or together,

or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.

(b) Explanation

- **1**. "Controlling ownership interest" means ownership of or entitlement t o more than twenty-five per cent. of shares or capital or profits of the company.
- 2. In case of a partnership firm, the beneficial owner is the naturalness on(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen perce nt of capital or profits of the partnership.
- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural perso n(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or e ntitlement to more than fifteen percent of the property or capital or profit s of such association or body of i ndividuals;
- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- VI. An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
- 7. **Anti Bribery Clause**: By participating in this tender, the suppliers/Vendor s/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such inciden thappening, they shall report it to Vigilance
