Liquidated Damages Clause**: If the supplier fails to deliver any or all of the goods or fails to perform t he services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other r ights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated d amages, a sum equivalent to the $\frac{1}{2}$ % percent of the delivered price of the delay ed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

6.By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that t hey shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or durin g the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.

7. Warranty Clause:

- (a) The supplier warrants that the goods supplied under the contract is new, un used, and incorporate all recent improvements in design and materials unless p rescribed otherwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as p er SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the c onditions prevailing in India.
- (b) This warranty shall remain valid for twelve months after the goods or any portion thereof as the case may be, have been delivered to the final destination and installed and commissioned at the final destination and accepted by SPMCIL in terms of the contract.
- (c) In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- (d) Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.
- (e) In the event of any rectification of a defect or replacement of any defective g oods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPMCIL.
- (f) If the supplier, having been notified, fails to rectify/ replace the defect(s) with in a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPMCIL may have against the supplier.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

- 7. Floating / creation of work contracts as Custom Bids in Services.
