1. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural perso n(s), who, whether acting al one or together, or through one or more juridical person, has owner ship of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of i ndividuals;

4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant n atural person who holds the position of senior managing official.

5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership. VI. An A gent is a person employed to do any act for another, or to represent another in dealings with third person.

# 9. Warranty Clause:

(a) The supplier warrants that the goods supplied under the contract is new, un used, and incorporate all recent improvements in design and materials unless p rescribed otherwise by SPMCIL in the contract. The supplier further warrants tha t the goods supplied under the contract shall have no defect arising from design , materials (except when the design adopted and / or the material used are as p er SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the c onditions prevailing in India.

(b) This warranty shall remain valid for twenty-four months after the goods or a ny portion thereof as the case may be, have been delivered to the final destination and installed and commissioned at the final destination and accepte d by SPMCIL in terms of the contract-

(c) In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.

(d) Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.

(e) In the event of any rectification of a defect or replacement of any defective g oods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectif ied / replaced goods starts functioning to the satisfaction of SPMCIL.

(f) If the supplier, having been notified, fails to rectify/ replace the defect(s) with in a reasonable period (or within the period, if specified in the SCC), SPMCIL ma y proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk a nd expense of the supplier and without prejudice to other contractual rights and remedies, which SPMCIL may have against the supplier.

**10. - 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
