- 1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and

based on competitive prices received in Bid / RA process.

Bidders are bound to accept the orders accordingly.

#### (iii) Financial Standing:-

- (1) The average annual financial turnover of the bidder firm (manufacturer or principal of authorize d deal er) during the last three years, ending on '31.03.2024' should be at least Rs.16,41,660/- on 31.03.2024 as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authent icated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.

**Note 2:** For MSEs and Start-ups (registered for the tendered item) all financial criteria & Experience and p ast performance criteria shall be exempted. However, its capacity and capability may be verified (if necess ary) by the buyer.

- 2. **Applicability to 'Make in India':** Bidders (manufacturer or principal of authorized representative) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. I ii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.
- 3. For Authorized Representatives: Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable ten der-specific authorization in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been

associated, as authorized representative of the same or other Principal Manufacturer for same set of servic es as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 'The Relevant Date'.

4. **For Existing successful Past Suppliers**: In case the bidder (manufacturer or principal of authorized r epresentative) who is a successful past supplier of SITC of intelligent wired addressable system in at least

one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or m ore of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL.

- 5. **Joint Ventures and Holding Companies**: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial S tanding Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- 6. **Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Start-up ent erprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. - 8. **Liquidated Damages:** If the supplier fails to deliver any or all of the goods or fails to perform the servi ces within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights an d remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% of the delivered price of the delayed goods and/ or services for each week of d elay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).
- 9. **GST return**: The Supplier should file the GST returns for outward supplies in time. In case of any input credit loss to BNP by way of their failure to file GST returns in time, BNP reserves the right to with old the p ayment of further supplies till production of evident of filling of returns.

10. Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1, 2 and 3) F.No.6/18/2019- PPD dated 23rd/ 24th July 2020 (or any further am endments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. Salient features of this are:

I. - (e) An Indian (or other) agent of such an entity; or
- (f) A natural person who is a citizen of such a country; or
- (g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above

V. The beneficial owner for the purpose of (III) above will be as under: (a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s). Who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.

### (b) Explanation

- **1**. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. of shares or capital or profits of the company.
- 2. In case of a partnership firm, the beneficial owner is the naturalness on(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen perce nt of capital or profits of the partnership.
- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural perso n(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profit s of such association or body of i

ndividuals:

- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant n atural person who holds the position of senior managing official.
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- VI. An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
- 11. The bidder, on whom contract will be placed, will have to submit price breakup as per bill of material a ttached to section XI of technical specifications.
- 12. The participating bidder shall visit the site before bidding. The site visit certificate will be i ssued by BNP authority and it is mandatory to submit the certificate along with the bid docum ent at the time participation failing which the bid shall not be considered.

**Note**: The firms who has already been visit the site against GeM bid no.GEM/2024/B/5452401 dated 25.10 .2024 they do not need to visit site again and it is mandatory to enclosed the certificate of site visit with the bid documents.

## 13. Warrantee Clause:-

- (i) The supplier warrants that the goods supplied under the contract is new, unused, and incorporate all recent improvements in design and materials unless prescribed ot herwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as per SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
- (ii) This warranty shall remain valid for 03 years after the goods or any portion thereof as the case may be, have been delivered to the final destination and installed and commissioned at the final destination and accepted by SPMCIL in terms of the contract or for Thirty Nine months from the date of despatch from the supplier's premises for domestic goods (including goods already imported by the supplier under its own arrangement) or for Forty Two months after the date of shipment from the port of loading in the source country for imported goods offered from abroad, whichever is earlier.
- (iii) In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- (iv) Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts the ereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.
- (v) In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPMCIL.
- (vi) If the supplier, having been notified, fails to rectify/ replace the defect(s) within a

reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SP MCIL may have against the supplier.
