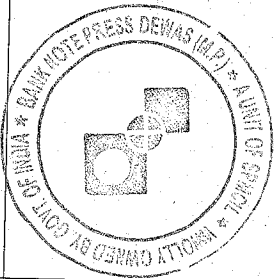

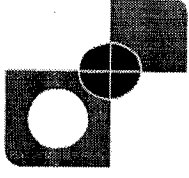

The box should be delivered in complete assembled condition leaving the top lid open. BNP management may provide open space inside BNP premises on rental basis (as per rule & regulation of BNP) for assembling of Block Board Boxes on request of successful bidder, if required.

Technical Specification, Buyer Specification Document, Technical Specification, TERMS & CONDITIONS OF CONTRACT, Sr. No. 4	The boxes should be neat, clean & uniform in dimension & as per specification." In the event of random check after the supplies are made, the block boards are found not conforming with specification & terms & conditions, the entire lot will be rejected, The rejected lot will be removed from BNP by the supplier at his own cost within 30 days failing which BNP will take action to remove the material at risk & cost of supplier.	The boxes should be neat, clean & uniform in dimension & as per specification. The successful firm have to supply boxes as per their delivery schedule. In event of random check of block board boxes on machine or in packing section, if any box is found damaged or deviating from desired specifications, then the same will be rejected. The supplier firm will have to pick the rejected boxes from BNP & replace it by good boxes at his own cost.
