- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 4. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after

evaluation of documents submitted.

- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original

delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

- 2. At the time of submitting the offer, bidder has to submit the sealed and signed bid doc ument as an acceptance of all additional terms and conditions, technical specification a nd payment terms as mentioned in bid.
- 3. The bidder firm should meet following eligibility criteria to qualify:
 - A. Capability, Equipment and Manufacturing facilities: The Bidder must have an a nnual capacity to manufacture & supply at least 3200 EA of tendered item.

The bidder has to submit the following details along with the bid.

- (i) Name of the machine utilized to supply the quoted product.
- (ii) The number of machines being utilized for the production and the capacity of e ach machine.
- (iii) Total annual capacity of manufacturer.
- (iv) Supply orders in hand and proportionate capacity to supply quoted amount.

Note:

- Participating bidder needs to submit all related documents along with the bid.
- 2. All the discretion of the purchaser, the capacity & capability assessment/ verific ation of bidder/manufacturer firms shall be undertaken by technical committee or through a third party technical consultancy/ inspection agencies to ensure th at firms are identified and capable to develop the item as required.
- 4. Applicability to 'Make in India': Bidders (manufacturer or principal of authorized representati ve) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transf er of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qu alified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for te chnology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. Iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.
- 5. For Authorized Representatives: Bids of bidders quoting as authorized representative of a pri ncipal manufacturer would also be considered to be qualified, provided: i) their principal manufact urer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorization in the prescribed form assuring full guarantee an d warranty obligations as per the general and special conditions of contract; and iii) the bidder him self should have been associated, as authorized representative of the same or other Principal Man ufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioni)

- 6. **For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of **Block Board Boxes** in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), we ho do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL.
- 7. **Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goo ds/Equipment, and each partner must comply with all the PQC criteria independently. How ever, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing c redentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- 8. **Start-up Enterprises:** Requirements of prior experience and turnover would be relaxe d for Start-up enterprises as recognized by Department for Promotion of Industry and Inte rnal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such S tart-ups maybe either MSE or otherwise.

9. **Notes for Bidders:**

- (i) Along with all the necessary documents/ certificates required as per the tender conditions, the bidder should furnish a brief write-up, backed with adequate data, explaining his available capacity (both technical and financial), for manufac ture and supply of the required goods/ equipment, within the specified time of co mpletion, after meeting all their current commitments.
- (ii) Supporting documents submitted by the bidder must be certified as follows:

- (iv) All financial standing data should be certified by certified accountants, for exa mple, Charted Accountants/ Cost Accountants in India and equivalent in relevant countries; and
- (v) Indian bidder or Indian counterparts of foreign bidders should furnish their Per manent Account Number.
- 10. **LD Clause:** If the supplier fails to deliver any or all of the goods or fails to perform the s ervices within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the c

ontract price, as liquidated damages, a sum equivalent to the ½% percent of the delivere d price of the delayed goods and/ or services for each week of delay or part thereof until a ctual delivery or performance, subject to a maximum deduction of the 10% of the delaye d goods' or services' contract price(s).

- 11. "**GST Return**: Supplier should file the GST returns for outward supplies in time. In case of any Input credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."
- 12. **Capacity verification (if required)**: As part of technical evaluation, if required capacit y verification of the bidders may be conducted by BNP. The offer of the firms not meeting the criteria in verification as per bid document will be rejected.
- 13. "By participating in this tender, the suppliers/Vendors/Contractors are deemed to have u ndertaken that they shall not give or take, any financial or non-financial bribe, to or from a nyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance."
- 14. **Warrantee Clause:** The warranty shall be applicable only for 3 months from the date of last supply/delivery. If the supplier, having been notified, fails to rectify/ replace the defec t(s) within a reasonable period, BNP may proceed to take such remedial action.

- (a) In case of a company or Limited Liability Partnership, the beneficial owner is the nat ural person(s). Who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other me ans.
- (b) Explanation-
- 1. "Controlling ownership interest" means ownership of or entitlement to more than tw enty-five per cent. of shares or capital or profits of the company.
- 2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whet her acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership.
- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial ow ner is the relevant natural person who holds the position of senior managing official.
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more int erest in the trust and any other natural person exercising ultimate effective control ove r the trust through a chain of control or ownership.
- VI. An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
