- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. - 5. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2. At the time of submitting the offer, bidder has to submit the sealed and signed bid document as an acceptance of all additional terms and conditions, technical specification and payment terms as mentioned in bid.

- **3.** The bidder firm should meet following eligibility criteria to qualify:
 - **A. Experience & Past Performance: -** The bidder should have manufactured and suppli ed tendered item of at least **18400 EA** in any one of last five years ending on 31.03.202 4
 - **B.** Capability, Equipment and Manufacturing facilities: The Bidder must have an annual capacity to manufacture & supply at least **18400 EA** of tendered item.

The bidder has to submit the following details along with the bid.

- (i) Name of the machine utilized to supply the quoted product.
- (ii) The number of machines being utilized for the production and the capacity of each machine.
- (iii) Total annual capacity of manufacturer.
- (iv) Supply orders in hand and proportionate capacity to supply quoted amount.

C. Financial standing:

- 4. Applicability to 'Make in India' :Bidders (manufacturer or principal of authorized represen tative) If the product is being manufactured in India under a license from a foreign manufacturer who hold s intellectual property rights and where there is a technology collaboration agreement/ transfer of technolo gy agreement for indigenous manufacture of a product developed abroad with clear phased increase in loc al content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experi ence and Past Performance above, would also be considered to be qualified provided: i) their foreign manu facturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in lo cal content. Iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfa ctory manufacture, Supply (and erection, commissioning if applicable) and performance of 'HDPE woven b ag' offered including all warranty obligations as per the general and special conditions of contract.
- **5. For Authorized Representatives:** Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enfor ceable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligation

s as per the general and special conditions of contract; and iii) the bidder himself should have been associa ted, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for s ame or **similar 'HDPE woven bag'** for past three years ending on '31st March 2024'.

- **6. For Existing successful Past Suppliers:** In case the bidder (manufacturer or p rincipal of authorized representative) who is a successful past supplier of HDPE woven bag in at le ast one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not m eet any or more of requirements above, would also be considered to be qualified in view of their p roven credentials, for the maximum quantity supplied by him in such recent past to any units of S PMCIL.
- 7. **Joint Ventures and Holding Companies:** Credentials of the partners of Joint v entures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goo ds/Equipment, and each partner must comply with all the PQC criteria independently. However, fo r the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, w ith appropriate legal documents proving such ownership.
- **8. Start-up Enterprises:** Requirements of prior experience and turnover would be relaxe d for Start-up enterprises as recognized by Department for Promotion of Industry and Internal Tra de (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

9. Notes for Bidders:

- (i) Along with all the necessary documents/ certificates required as per the tender c onditions, the bidder should furnish a brief write-up, backed with adequate data, e xplaining his available capacity (both technical and financial), for manufacture and supply of the required goods/ equipment, within the specified time of completion, after meeting all their current commitments.
- (ii) Supporting documents submitted by the bidder must be certified as follows:
- (iii) All copy of supply/ work order; respective completion certificate and contact details of clients; documents issued by the relevant industries department; National Small Industries Corporation (NSIC); manufacturing licence, annual report, etc., in support of experience, past performance and capacity/ capability should be authenticated by the by the person authorized to sign the tender on behalf of the bidder.
- (iv) All financial standing data should be certified by certified accountants, for examp le, Charted Accountants/ Cost Accountants in India and equivalent in relevant coun tries; and
- (v) Indian bidder or Indian counterparts of foreign bidders should furnish their Perma nent Account Number.
- 10. **LD Clause** If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to o ther rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed

goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

- **11. "GST Return**: Supplier should file the GST returns for outward supplies in time. In case of any In put credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."
- **12. Capacity verification (if required)**: All the discretion of the purchaser, the capacity & capabili ty assessment/ verification of bidder/manufacturer firms shall be undertaken by technical commit tee or through a third party technical consultancy/ inspection agencies to ensure that firms are id entified and capable to develop the item as required.

As part of technical evaluation, if required capacity verification of the bidders may be conducted by BNP. The offer of the firms not meeting the criteria in verification as per bid document will be rejected.

- 13. "By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertak en that they shall not give or take, any financial or non-financial bribe, to or from anyone during t he tender or during the execution of the contract thereafter and if they notice any such incident h appening, they shall report it to Vigilance."
- **14. Warrantee Clause:** The warranty shall be applicable only for 3 months from the date of last su pply/delivery. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a re asonable period, BNP may proceed to take such remedial action.
- 15. Delivery Schedule: Total Quantity 46000 (+/-5%)

The successful bidder (only for new supplier) shall submit 2 nos. completely assembled HDPE packing bags for the approval as representative sample before executing the bulk supply. (No payme nt will be made by BNP for un-suitable & material consumed during pre-production trials). After c onfirmation of suitability of trial lot from BNP, the firm has to supply material as per delivery schedule given below -

- 1. 1st installment of 30% (+/-5%) bags within 40 days from the date of issue of GeM contract.
- 2. 2^{nd} installment of 30% (+/-5%) bags within 70 days from the date of issue of GeM contract.
- 3. 3rd installment of 40% (+/-5%) bags within 100 days from the date of issue of GeM contract.

Note: The allowed variation would be +/-5% under no circumstances, material will be accepted beyo nd +/-5% allowed quantity tolerance. Any variation in periodic rate of supply more than -5% in eac h delivery schedule would be considered as delay in delivery and LD will be imposed on such short supply in which quantity is beyond -5% of each delivery.

We hereby certify that we fulfill all requirements in this regard and are eligible to be considered."

II. - 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.

5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.

VI. An Agent is a person employed to do any act for another, or to represent another in deal ings with third person.
