1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of

guality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

# Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्त

## 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. Buyer Added Bid Specific ATC

2. The participating firm has to submit sealed and signed bid document as an a cceptance of all terms and conditions, technical specification and payment term s as mentioned in bid.

**3. LD Clause**: If the supplier fails to deliver any or all of the goods or fails to per form the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under t he contract, deduct from the contract price, as liquidated damages, a sum equi valent to the  $\frac{1}{2}$  % percent of the delivered price of the delayed goods and/ or se rvices for each week of delay or part thereof until actual delivery or performanc e, subject to a maximum deduction of the 10 % of the delayed goods' or service s' contract price(s).

4. **"GST Return:** Supplier should file the GST returns for outward supplies in ti me. In case of any Input credit Loss to BNP by way of their failure to files GST re turns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."

5. **Anti Bribery Clause** : By participating in this tender, the suppliers/Vendors/ Contractors are deemed to have undertaken that they shall not give or take, an y financial or non-financial bribe, to or from any one during the tender or during the execution of the contract thereafter and if they notice any such incident hap pening, they shall report it to Vigilance.

**6. Ban/Blacklisting undertaking** : You are requested to submit the Undertak ing/Declaration certificate that you are currently not suspended/Banned/Blacklis ted by any ministry/department of govt. of India or by any state govt. for busine ss dealing.

**7. Land Border sharing clause :** Ministry of Finance, Department of Expendit ure, Public Procurement Division, Orders (Public Procurement 1, 2 and 3) F.No.6/18/2019-PPD dated 23rd/ 24th July 2020 (or any further amendments th ereof) regarding eligibility of bidders from specified countries shall be applicabl e to this tender. Salient features of this are:

I. Any bidder from a country which shares a land border with India (excluding co untries as listed on the website of Ministry of External Affairs, to which the Gove rnment of India has extended lines of credit or in which the Government of India is engaged in development projects) will be eligible to bid in this tender only if t he bidder is registered with the Registration Committee constituted by the Dep artment for Promotion of Industry and Internal Trade (DPIIT). The bidders shall e nclose following certificate in this regard:

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; and solemnly certify that we are not from such a country or, if from such a country, we are registered with th e Competent Authority (copy enclosed). We hereby certify that we fulfill all requ irements in this regard and are eligible to be considered."

II. In tenders for Turnkey contracts including Works contracts, the successful bid der shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is similarly register ed with the Registration Committee constituted by the Department for Promotio n of Industry and Internal Trade (DPIIT). In such cases the bidders shall enclose f ollowing certificate:

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India and on sub-contracting to co ntractors from such countries,; and solemnly certify that we are not from such a country or, if from such a country, we are registered with the Competent Author ity (copy enclosed) and we will not subcontract any work to a contractor from s uch countries unless such contractor is registered with the Competent Authorit y. We hereby certify that we fulfill all requirements in this regard and are eligibl e to be considered."

III. "Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in c ertain contexts) means any person or firm or company, including any member o f a consortium or joint venture (that is an association of several persons, or firm s or companies), every artificial juridical person not falling in any of the descripti ons of bidders stated herein before, including any agency branch or office contr olled by such person, participating in a procurement process.

IV. "Bidder from a country which shares a land border with India" for the purpos e of this Order means:-

(a) An entity incorporated, established, or registered in such a country; or

(b) A subsidiary of an entity incorporated, established, or registered in such a c ountry; or

(c) An entity substantially controlled through entities incorporated, established, or registered in such a country; or

(d) An entity whose beneficial owner is situated in such a country; or

(e) An Indian (or other) agent of such an entity; or

(f) A natural person who is a citizen of such a country; or

(g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above

V. The beneficial owner for the purpose of (III) above will be as under:

(a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s). Who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises con trol through other means.

(b) Explanation-

1. "Controlling ownership interest" means ownership of or entitlement to more t han twenty-five per cent. of shares or capital or profits of the company.

2. In case of a partnership firm, the beneficial owner is the natural person(s) wh o, whether acting alone or together, or through one or more juridical person, ha s ownership of entitlement to more than fifteen percent of capital or profits of th e partnership.

3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or throug h one or more juridical person, has ownership of or entitlement to more than fift een percent of the property or capital or profits of such association or body of in dividuals; 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.

5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.

VI. An Agent is a person employed to do any act for another, or to represent an other in dealings with third person.

# 8. Warranty Clause :

1. The supplier warrants that the goods supplied under the contract is new, unu sed, and in corporate all recent improvements in design and materials unless pr escribed otherwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as pe r SPMCIL's specifications) or workmanship or from any act or omission of the su pplier, that may develop under normal use of the supplied goods under the con ditions prevailing in India.

2. This warranty shall remain valid for twelve months after the goods or any por tion there of as the case may be, have been delivered to the final destination a nd installed and commissioned at the final destination and accepted by SPMCIL in terms of the contract.

3. In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.

4. Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.

5. In the event of any rectification of a defect or replacement of any defective g oods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectif ied / replaced goods starts functioning to the satisfaction of SPMCIL.

6. If the supplier, having been notified, fails to rectify/ replace the defect(s) withi n a reason able period (or within the period, if specified in the SCC), SPMCIL ma y proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk a nd expense of the supplier and without prejudice to other contractual rights and remedies, which SPMCIL may have against the supplier.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
