- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

- 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. - 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- i) The beneficial owner for the purpose of (g) above will be as under:
  - (a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person
  - (s). Who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.
  - (b) Explanation-
    - 1) "Controlling ownership interest" means ownership of or entitlement to more than twe nty-five per cent. of shares or capital or profits of the company.
    - 2) In case of a partnership firm, the beneficial owner is the natural person(s) who, wheth er acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership.
    - In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
    - 4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial own er is the relevant natural person who holds the position of senior managing official.
    - 5) In case of a trust, the identification of beneficial owner(s) shall include identification o f the author of the trust, the trustee, the beneficiaries with fifteen percent or more inte rest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- j) An Agent is a person employed to do any act for another, or to represent another in dealings with third p erson.
- k) By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that th ey shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.

- I) The bidder has to submit undertaking that shelf life of the material shall be minimum 24 months from th e date of supply of material at BNP Dewas.
- m) The Warranty period of the tendered product shall be 03 months from the date of acceptance of material at BNP Dewas.

    - iii) Total Annual capacity of Manufacturer

### C. Financial standing:

**Note:** MSEs and Start-ups are exempted from Eligibility Criteria 3(A) & 3(C). However, documents regarding 3(B) shall be verified.

#### **Applicability in Special Cases:-**

- 1) Applicability to 'Make in India': Bidders (manufacturer or principal of authorized representativ e) If the product is being manufactured in India under a license from a foreign manufacturer who hol ds intellectual property rights and where there is a technology collaboration agreement/ transfer of t echnology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of s ub-criteria in Experience and Past Performance above, would also be considered to be qualified prov ided:
  - i) their foreign manufacturer who holds intellectual property rights, meets all the crit eria above without exemption, and
  - ii) the Bidder submits appropriate documentary proof for technology collaboration ag reement/ transfer of technology agreement for indigenous manufacture of a product d eveloped abroad with clear phased increase in local content.
  - the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such fo reign Manufacturer for satisfactory manufacture, Supply (and erection, commissionin g if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.

- **2) Authorized Representatives:** Bids of bidders quoting as authorized representative of a princip al manufacturer would also be considered to be qualified, provided:
  - a. their principal manufacturer meets all the criteria above without exemption, and
  - b. the principal manufacturer furnishes a legally enforceable tender-specific authoris ation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and
  - c. the bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (su pply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 'The Relevant Date'.
- **3) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **4) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot ( repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **5) Development/ insufficient market capacity or Exceptional One-Off Cases:** These are thos e items which are either being newly developed where vendors are yet to be developed or for new/ existing items where the capacity available in market is inadequate compared to our annual require ments. Exceptional one-off cases are such items/ Plant & Machinery which are procured infrequently (say once in 3 years or longer periods). In such cases PQC Should be Decided with the approval of C FA in individual cases.
- **6) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Start -up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), su bject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or o therwise.

## 4. Delivery schedule:-

- -1st installment of 25% of total ordered quantity to be supplied within 30 days from the date of placing Co ntract.
- -2nd installment of 25% of total ordered quantity to be supplied within 60 days from the date of placing Co ntract.
- -3rd Installment of 25% of total ordered quantity to be supplied within 90 days from the date of placing Co ntract.
- -4th Installment of balance quantity to be supplied within 120 days from the date of placing Contract.

### **New Supplier -**

**Pre- Production Sample:-** New supplier has to supply pre-production sample in quantity of "1 KGs." with in 15 days from the date of placing of contract.

The firm on whom supply order will be placed will have to supply the material in 04 installments as mentio ned below:-

-1st installment of 25% of total ordered quantity (inclusive of Pre-Production sample quantity) to be supplie d within 45 days from the date of placing of contract. Quantity excluding the preproduction sample to be s

upplied after approval of the preproduction sample. However the net timeline for completion of the 1<sup>st</sup> inst allment shall be 45 days from the date of placement of contract.

- -2nd installment of 25% of total ordered quantity to be supplied within 60 days from the date of placing of contract.
- -3rd installment of 25% of total ordered quantity to be supplied within 90 days from the date of placing of contract.
