1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and

for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- (a) Experience & Past Performance:- The bidder (manufacturer or principal of authorized represe ntative hereinafter referred simply as 'The Bidder') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned Nickel Electroformi ng Vat Bath with the same or higher specifications of at least one number in last five years endin g on "31.03.2024". (c) Financial Standing:-

Iii) the bidder (manufacture of a product developed abroad with clear phased increase in local content. Iii) the bidder (manufacture r or principal of authorized representative) furnishes along with the bid a legally enforceable under taking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Su pply (and erection, commissioning if applicable) and performance of 'The Product' offered includin g all warranty obligations as per the general and special conditions of contract.
- 3. **For Authorized Representatives:** Bids of bidders quoting as authorized representative of a p rincipal manufacturer would also be considered to be qualified, provided: i) their principal manufac turer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorization in the prescribed form assuring full guarantee and

warranty obligations as per the general and special conditions of contract; and iii) the bidder himse If should have been associated, as authorized representative of the same or other Principal Manufa cturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 'The relevant date'.

- 4. **For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of auth orized representative) who is a successful past supplier of **Nickel Electroforming Vat Bath** in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of S PMCIL.
- 5. **Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, a nd each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate lega I documents proving such ownership.
- Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Sta rt-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either M SE or otherwise.

7. Notes for Bidders:

- (i) Along with all the necessary documents/ certificates required as per the tender conditions, th e bidder should furnish a brief write-up, backed with adequate data, explaining his available capa city (both technical and financial), for manufacture and supply of the required goods/ equipment, within the specified time of completion, after meeting all their current commitments.

Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform th e services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed g oods and/ or services for each week of delay or part thereof until actual delivery or performance, s ubject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

11. Warranty:

- (i) The supplier warrants that the goods supplied under the contract is new, unused, and incorpo rate all recent improvements in design and materials unless prescribed otherwise by SPMCIL i n the contract. The supplier further warrants that the goods supplied under the contract shall h ave no defect arising from design, materials (except when the design adopted and / or the mat erial used are as per SPMCIL's specifications) or workmanship or from any act or omission of th e supplier, that may develop under normal use of the supplied goods under the conditions pre vailing in India.
- (ii) This warranty shall remain valid for twelve months after the goods or any portion thereof as t he case may be, have been delivered to the final destination and installed and commissioned at the final destination and accepted by SPMCIL in terms of the contract or for fifteen months f rom the date of despatch from the supplier's premises for domestic goods (including goods alr eady imported by the supplier under its own arrangement) or for eighteen months after the da te of shipment from the port of loading in the source country for imported goods offered from a broad, whichever is earlier.
- (iii) In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writ ing to the supplier.
- (iv) Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at t he ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ good s thereafter.
- (v) In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further p eriod of twelve months from the date such rectified / replaced goods starts functioning to the s atisfaction of SPMCIL.
- (vi) If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedi al action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without preju dice to other contractual rights and remedies, which SPMCIL may have against the supplier.
- 12. **GST Return:** Supplier should file the GST returns for outward supplies in time. In case of any In put credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."
