The bill must be submitted in triplicate after disbursement among the workers within 5 days. Further, the agency shall furnish a copy of deposition of monthly EPF/ESIC challan returns along with etc. with the bill falling which amount as deemed fit by bank Note Press, Dewas shall with hold in the next subsequent bill. The payment must be made before estate Custodian/Officer (HR) or GM BNP representativ e, which should be duly authorized by him.
