- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation.  - (a) The supplier warrants that the goods supplied under the contract is new, unused, and incorporate all recent improvements in design and materials unless prescribed otherwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as per SPM CIL's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
 - (b) This warranty shall remain valid for twelve months after the goo ds or any portion thereof as the case may be, have been delivered t o the final destination and installed and commissioned at the final d estination and accepted by SPMCIL in terms of the contract.
 - (c) In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
 - (d) Upon receipt of such notice, the supplier shall, with all reasonabl

e speed (or within the period, if specified in the SCC), repair or repla ce the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods a fter providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.

- (e) In the event of any rectification of a defect or replacement of an y defective goods during the warranty period, the warranty for the r ectified/ replaced goods shall be extended to a further period of twe lve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPMCIL.
- (f) If the supplier, having been notified, fails to rectify/ replace the d efect(s) within a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and w ithout prejudice to other contractual rights and remedies, which SP MCIL may have against the supplier.

8. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
