If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. **5.** In case of a trust, the identification of beneficial owner(s) shall in clude identification of the author of the trust, the trustee, the beneficiaries with

fifteen percent or more interest in the trust and any other natural p erson exercising ultimate effective control over the trust through a chain of

control or ownership.

**VI.** An Agent is a person employed to do any act for another, or to r epresent another in dealings with third person.

(b) This warranty shall remain valid for twenty-four (24) months afte

(c) In case of any claim arising out of this warranty, SPMCIL shall pro mptly notify the same in writing to the supplier.

(d) Upon receipt of such notice, the supplier shall, with all reasonabl e speed (or within the period, if specified in the SCC), repair or repla ce the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods a fter providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.

(e) In the event of any rectification of a defect or replacement of an y defective goods during the warranty period, the warranty for the r ectified/ replaced goods shall be extended to a further period of twe lve months from the date such rectified / replaced goods starts func tioning to the satisfaction of SPMCIL.

(f) If the supplier, having been notified, fails to rectify/ replace the d efect(s) within a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and w ithout prejudice to other contractual rights and remedies, which SP MCIL may have against the supplier.

#### 8. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
