Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the

Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

5. <u>Warranty Clause</u> :

1. The supplier warrants that the goods supplied under the contract is new, unused, and inc orporate all recent improvements in design and materials unless prescribed otherwise by S PMCIL in the contract. The supplier further warrants that the goods supplied under the cont ract shall have no defect arising from design, materials (except when the design adopted a nd / or the material used are as per SPMCIL's specifications) or workmanship or from any ac t or omission of the supplier, that may develop under normal use of the supplied goods und er the conditions prevailing in India.

2. This warranty shall remain valid for twelve months after the goods or any portion thereof as the case may be, have been delivered to the final destination and installed and commiss ioned at the final destination and accepted by SPMCIL in terms of the contract.

3. In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same i n writing to the supplier.

4. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reason able period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and wit hout prejudice to other contractual rights and remedies, which SPMCIL may have against th e supplier.

6. **Anti-bribery clause** : By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financ ial bribe, to or from anyone during the tender or during the execution of the contract there after and if they notice any such incident happening, they shall report it to Vigilance.

7. GST Return:

Supplier should file the GST returns for outward supplies in time. In case of any Input credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to wit hhold the payment of further supplies till production of evidence of filling of returns.".

8. Liquidated Damages:
