1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. 12. Anti-bribery clause: By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from an yone during the tender or during the execution of the contract thereafter and if they notice any such i ncident happening, they shall report it to Vigilance.

13. Warrantee clause:

(a) The supplier warrants that the goods supplied under the contract is new, unused, and incorporate all recent improvements in design and m aterials unless prescribed otherwise by SPMCIL in the contract. The sup plier further warrants that the goods supplied under the contract shall h ave no defect arising from design, materials (except when the design a dopted and / or the material used are as per SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may deve lop under normal use of the supplied goods under the conditions prevail ing in India.

(b) This warranty shall remain valid for twelve months after the goods o r any portion thereof as the case may be, have been delivered to the fin al destination and installed and commissioned at the final destination a nd accepted by SPMCIL in terms of the contract.

(c) In case of any claim arising out of this warranty, SPMCIL shall promp tly notify the same in writing to the supplier.

(d) Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace th e defective goods or parts thereof, free of cost, at the ultimate destinati on. The supplier shall take over the replaced parts/ goods after providin g their replacements and no claim, whatsoever shall lie on SPMCIL for s uch replaced parts/ goods thereafter.

(e) In the event of any rectification of a defect or replacement of any de fective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months f rom the date such rectified / replaced goods starts functioning to the sa tisfaction of SPMCIL.

(f) If the supplier, having been notified, fails to rectify/ replace the defec t(s) within a reasonable period (or within the period, if specified in the S CC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without prejudic e to other contractual rights and remedies, which SPMCIL may have ag ainst the supplier.

- **14. Documents Checklist:-** The participating bidder shall also submit the documents as per following mentioned order:-
 - (i) Seal & signed Bid/Tender document as an unconditional acceptance of all terms & conditions o f bid.
 - (ii) Seal & signed technical specifications.
 - (iii) Latest Udyam Certificate, if bidder is claiming any benefits against MSE Policy.
 - (iv) Audited Balance sheet & Profit and loss statement of FY 2021-22, FY2022-23 & FY 2023-24 dul y certified by Chartered Accountant/ Cost Accountant in India or equivalent in relevant countrie s.
 - (v) Undertaking/Declaration certificate that you are currently not suspended/Banned/Blacklisted by any ministry/ department of govt. of India or by any state govt. for business dealing.
 - (vi) Catalogue of the offered product.
 - (vii) Compliance of land border sharing clause in the format mentioned above.

15. Note for bidders:

i. Along with all the necessary documents/ certificates required as per the bid conditions, the bid der should furnish a brief write-up, backed with adequate data, explaining his available capacity (both technical and financial), for manufacture and supply of the required goods/ equipment, wi thin the specified time of completion, after meeting all their current commitments.

- **ii.** Supporting documents submitted by the bidder must be certified as follows:
- **a.** All copy of supply/ work order; respective completion certificate/Invoice copy and contact detail s of clients; documents issued by the relevant Industries Department; National Small Industries Corporation (NSIC); manufacturing licence, annual report, etc., in support of experience, past p erformance and capacity/ capability should be authenticated by the by the person authorised to sign the tender on behalf of the bidder.
- **b.** All financial standing data should be certified by certified accountants, for example, Chartered Accountants/ Cost Accountants in India and equivalent in relevant countries; and

8. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
