its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - 7. 12. Warranty clause:

- a. The supplier warrants that the goods supplied under the contract is new, unused, and incorpo rate all recent improvements in design and materials unless prescribed otherwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as per SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
- b. This warranty shall remain valid for twenty-four months after the goods or any portion thereof as the case may be, have been delivered to the final destination and installed and commission ed at the final destination and accepted by SPMCIL in terms of the contract.
- c. In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- d. Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.

 - (iii) Latest Udyam Certificate, if bidder is claiming any benefits against MSE Policy.
 - (iv) Audited Balance sheet & Profit and loss statement of FY 2021-22, FY2022-23 & FY 2023-24 dul y certified by Chartered Accountant/ Cost Accountant in India or equivalent in relevant countrie
 - (v) Submit documents as per para No.4 of technical specications.
 - (vii) Declaration regarding local content with details of location at which value addition activity is be ing done, if bidder has applied for Make in India purchase preference.
 - (Note: 60% local content is must to be eligible to claim purchase preference under Make i n India Policy as Class I local supplier as per Annexure I attached to Ministry of Powe r Order dated 23.04.2024.
 - (viii) Undertaking/Declaration certificate that you are currently not suspended/Banned/Blacklisted by

any ministry/ department of govt. of India or by any state govt. for business dealing.

15. Note for bidders:

- i.
