- 2. Sealed and Signed GeM Bid (Tender) Document as an unconditional acceptance of all terms and conditions, technical specification and payment terms as mentioned in the bid.
- 3. Sealed and Signed technical specification/ Scope of work (attached in the Bid Document.)
- 4. You are requested to submit the Undertaking/Declaration certificate that you are currently not s uspended/Banned/Blacklisted by any ministry/department of govt. of India or by any state govt. fo r business dealing.
- 5. Undertaking for compliance of land border sharing clause.

Note: Participating bidder needs to submit all related documents along with the bid.

7. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
