BNP Dewas has floated GeM bid No. GEM/2024/B/5102305, dated 23-07-2024 for procurement of PoF Shrink Film 355M W DIA 450M. Further, in this bid M/s Satyam Polymers, Raipur emerged as L1 firm and therefore GeM contract no. GEMC- 511687730539460 dated 20.12.2024 placed to the firm of value Rs. 5,89,050/-. However, firm has not supplied the material strictly as per technical specification of bid after placing the GeM Contract.
