- 1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at

the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Anti-bribery clause**: By participating in this tender, the suppliers/Vendors/Contractors ar e deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereaft er and if they notice any such incident happening, they shall report it to Vigilance.
- **9.** Warranty Clause:
- a. The supplier warrants that the goods supplied under the contract is new, un used, and inc orporate all recent improvements in design and materials unless prescribed otherwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopte d and / or the material used are as per SPMCIL's specifications) or workmanship or from an y act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
- **b.** This warranty shall remain valid for twelve months after the goods or any portion thereof as the case may be, have been delivered to the final destination and installed and commis sioned at the final destination and accepted by SPMCIL in terms of the contract.
- **c.** In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- **d.** Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the per iod, if specified in the SCC), repair or replace the defective goods or parts thereof, free of c ost, at the ultimate destination. The supplier shall take over the replaced parts/ goods afte r providing their replacements and no claim, whatsoever shall lie on SPMCIL for such repla ced parts/ goods thereafter.
- **e.** In the event of any rectification of a defect or replacement of any defective goods during t he warranty period, the warranty for the rectified/ replaced goods shall be extended to a f urther period of twelve months from the date such rectified / replaced goods starts functio ning to the satisfaction of SPMCIL.
- **f.** If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to ta ke such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPMCIL may have a gainst the supplier.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
