1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.

2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
3. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.

4. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.

5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. 1. The bidder firm should meet following eligibility criteria to qualify:

(i) Experience & Past Performance: - The bidder (manufacturer or principal of authorized representative – h ereinafter referred simply as 'The Bidder') shall be a manufacturer that has regularly for at least the last th ree years completed SITC and retro-fitting of SDB & replacement of feeder pillar with the same or higher s pecifications of at least one number in last five years ending on "31.03.2024". At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid openin g.

(ii) Capability- Equipment & manufacturing Facilities:- The bidder must have an annual capacity to manufa cture and supply at least 01 similar SITC and retro-fitting of SDB & replacement of feeder pillar.

Note: At the discretion of the purchaser, the capacity & capability assessment/ verification of bidder /manu facturer firms shall be undertaken by technical committee or through a third party technical consultancy/i nspection agencies to ensure that firms are identified and capable to develop the item as required.

(iii) Financial Standing:-

(1) The average annual financial turnover of the bidder firm (manufacturer or principal of authorized dealer) during the last three years, ending on '31.03.2024' should be at least 40% of the estimated cost or equivalent in foreign currency at exchange rate prevailing on 31.03.2024 as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a Chartered Account ant/ Cost Accountant in India or equivalent in relevant countries.

(2) The net worth of the firm should

a. not be negative on '31.03.2024' and

b. not have eroded by more than 30% in the last three years, ending on '31.03.2024'.

Note 1: To ascertain criteria net worth of initial and last financial year shall be compared. To ascertain finan cial standing criteria, bidders must submit seal & signed Balance Sheet & Profit and loss statement of last 3 financial year i.e. FY 2021-22, FY2022-23 & FY 2023-24, duly certified by Chartered Accountants/ Cost Ac countants.

Note 2: For MSEs and Start-ups (registered for the tendered item) all financial criteria & Experience and pa st performance criteria shall be exempted. However, its capacity and capability may be verified (if necessa ry) by the buyer.

2. Applicability to 'Make in India': Bidders (manufacturer or principal of authorized representative) If th e product is being manufactured in India under a license from a foreign manufacturer who holds intellectu al property rights and where there is a technology collaboration agreement/ transfer of technology agreem ent for indigenous manufacture of a product developed abroad with clear phased increase in local content,

and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Pa st Performance above, would also be considered to be qualified provided: i) their foreign manufacturer wh o holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder subm its appropriate documentary proof for technology collaboration agreement/ transfer of technology agreem ent for indigenous manufacture of a product developed abroad with clear phased increase in local content. Iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manuf acture, Supply (and erection, commissioning if applicable) and performance of 'SITC and retro-fitting of SD B & replacement of feeder pillar' offered including all warranty obligations as per the general and special c onditions of contract.

3. For Authorized Representatives: Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable ten der-specific authorization in the prescribed form assuring full guarantee and warranty obligations as per th e general and special conditions of contract; and iii) the bidder himself should have been associated, as au thorized representative of the same or other Principal Manufacturer for same set of services as in present b id (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or si milar 'SITC and retro-fitting of SDB & replacement of feeder pillar' for past three years ending on '31.03.20 24'.

4. For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorized r epresentative) who is a successful past supplier of SITC and retro-fitting of SDB & replacement of feeder pi llar in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL.

5. Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial S tanding Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

6. Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Start-up en terprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

11. Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform the ser vices within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damag es, a sum equivalent to the ½% of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% o f the delayed goods' or services' contract price(s).

14. Note for bidders:

i. Along with all the necessary documents/ certificates required as per the bid conditions, the bidder shoul d furnish a brief write-up, backed with adequate data, explaining his available capacity (both technical and financial), for manufacture and supply of the required goods/ equipment, within the specified time of comp letion, after meeting all their current commitments.
