Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

4. **Duration of Contract:** The above work will be on rate contract basis for a period of two year. If the service of transportation found satisfactory BNP may extend the contract for one more year.
5. The vehicle may be closed body container or open body. In any case the materials should not be damaged in transit. In case transportation of 200 litres capacity drum maximum no. of drums has to be delivered. (The minimum quantity is 72 nos. empty drums.)
