- 1. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

(1) Pre-production sample: 1st lot of 20 kgs trial rolls within 30 days from the date of issue of GeM contract for trial and suitability.
Suitability shall be given within 15 days after receipt of material and actual trial on machine (No p ayment will be made for un-suitable and consumed rolls during pre-production trials).
(2) After confirmation from BNP, the firm will supply 600 kgs of material within 60 days from the d ate of issue of GeM contract.
(3) The firm will supply remaining quantity of material within 90 days from the date of issue of Ge M contract.
Note: The allowable periodic variation would be +/-5%. Under no circumstances, material will be a ccepted beyond +5% allowed quantity tolerance. Any variation in periodic rate of supply more than -5% in each delivery schedule would be considered as delay in delivery and LD will be im posed on such short supply in which quantity is beyond -5% of each delivery.
11. Quantity Tolerance: The seller shall be allowed a tolerance of +/- 5% on the ordered quantity. This tolerance is to simplify logistical constraints and accounting of material. If seller supplies quantity beyond tolerance limit (except quantity procure through option clause) then such mat erial shall not be accepted and no payment shall be made for such supplies.
