- **3) For Existing successful Past Suppliers:** In case the bidder who is a successful past service provider of Manpo wer Outsourcing services in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more of requirements above, would also be considered to be qualified in view of their prove n credentials, for the maximum manpower services supplied by him in such recent past to any units of SPMCIL. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **4) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **5) Development/ insufficient market capacity or Exceptional One-Off Cases:** These are those items which a re either being newly developed where vendors are yet to be developed or for new/ existing items where the capacity available in market is inadequate compared to our annual requirements. Exceptional oneoff cases are such items / Plant & Machinery which are procured infrequently (say once in 3 years or longer periods). In such cases PQC Should be Decided with the approval of CFA in individual cases.
- **6) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Start-up enterprises as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

10. Documents Checklist:-

The participating bidder has to submit the documents as per following mentioned order:-

- b. For Other Firms: Experience and Past Performance :- Purchase Order copy(s) along with Tax Invoice(s) with self-c ertification by the bidder that supplied against the in voices have been executed. Any other document in support of order execution like work completion certificate etc.
- 3. Documents regarding Financial Standing: Balance sheet and Profit & Loss Statement for last 03 financial years en ding on 31 st March 2024 duly certified by Chartered Accountant.
- 4. Sealed and Signed GeM Bid (Tender) Document.
- 5. Sealed and Signed Scope of work (as attached in the bid document.)
- 6. Undertaking/Declaration certificate that you are currently not suspended/Banned/Blacklisted by any ministry/depa rtment of govt. of India or by any state govt. for business dealing and land border sharing clause undertaking.

11. Note:-

a) After accepting the contract additional SD must be deposited by firm whenever financial implication would be am ended due to minimum wages revision/increment of working days/increment of manpower strength etc.

b) The quoted rates shall not be less than the minimum wage fixed/notified by the State Government – where the se rvice is performed and shall include all statutory obligations. However bids with any element of cost over and above such minimum wage (or below it) shall be treated as 'Nil' price quotation and would be rejected. The service provide r shall be liable for all kinds of dues payable in respect of all personnel provided under the contract and the Procurin g Entity shall not be liable for any dues for availing the services of the personnel. The service provides hould ensure that persons to be deployed are not alcoholic, drug addict and not indulge in any activity prejudicial to the interest of the Procuring Entity. The service provider shall ensure to get the Police verification for all the manpower deployed by them and the contractor should ensure that the manpower deputed should bear good moral character.

c) Participating bidder needs to submit all related documents along with the bid.

8. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
