- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. - 6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

- 2. At the time of submitting the offer, bidder has to submit the sealed and signed bid document as an acce ptance of all additional terms and conditions, technical specification and payment terms as mentioned in bid.
- 3. The bidder firm should meet following eligibility criteria to qualify:
- A. Capability, Equipment and Manufacturing facilities: The Bidder must have an annual capacity to manufacture & supply at least 8000 kgs of tendered item.

The bidder has to submit the following details along with the bid.

- (i) Name of the machine utilized to supply the guoted product.
- (ii) The number of machines being utilized for the production and the capacity of each machine.
- (iii) Total annual capacity of manufacturer.
- (iv) Supply orders in hand and proportionate capacity to supply quoted amount.

Note:

- 1. Participating bidder needs to submit all related documents along with the bid.
- 2. All the discretion of the purchaser, the capacity & capability assessment/ verification of bidder/manufact urer firms shall be undertaken by technical committee or through a third party technical consultancy/ insp ection agencies to ensure that firms are identified and capable to develop the item as required.

Iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.
- 5. **For Authorized Representatives:** Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable ten der-specific authorization in the prescribed form assuring full guarantee and warranty obligations as per th e general and special conditions of contract; and iii) the bidder himself should have been associated, as au thorized representative of the same or other Principal Manufacturer for same set of services as in present b id (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or si milar 'Product' for past three years ending on 'The Relevant Date'.

9. Notes for Bidders:

- 11. "**GST Return:** Supplier should file the GST returns for outward supplies in time. In case of any Input cr edit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the p ayment of further supplies till production of evidence of filling of returns."
- 12. **Capacity verification (if required):** As part of technical evaluation, if required capacity verification of the bidders may be conducted by BNP. The offer of the firms not meeting the criteria in verification as per bid document will be rejected.
- 13. **Anti Bribery Clause -** "By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident ha ppening, they shall report it to Vigilance."
- 14. **ZED & LEAN Certification:** Government of India has launched scheme for obtaining ZED & LEAN cert ification to MSE vendors. Accordingly bidders are requested to obtain these certification to ensure minimu m wastage in production process which shall ultimately result In cost cutting & improvement in efficiency.

- 16. **Warrantee Clause:** The warranty shall be applicable only for 3 months from the date of last supply/d elivery. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable perio d, BNP may proceed to take such remedial action.
- 17. **Duration of security deposit :** Security deposit should be valid for 60 days beyond completion of all contractual obligation including warranty period. In case if material is replaced/rectified during warranty period then supplier must extend the warranty period as well as validity of security deposit.
- 18. **Quantity Tolerance:** The seller shall be allowed a tolerance of +/- 5% on the ordered quantity. This t olerance is to simplify logistical constraints and accounting of material. If seller supplies quantity beyond t olerance limit (except quantity procure through option clause) then such material shall not be accepted an d no payment shall be made for such supplies. Also if seller supplies less quantity than tolerance limit with in stipulated delivery period then it shall be consider as supply shortfall.

Before bulk production, pre production sample of two roll fulfilling all technical specification of the shrink film should be supplied within 15 days from the date of issue of GeM contract for inspection and machine testing. After receiving the sample material at BNP store, BNP will provide suitability report within 07 w orking days after receiving of material at BNP store.
- 2. 1st installment of 30 % of total ordered quantity within 45 days from the date of issue of GeM contract.
- 3. 2nd installment of 35 % of total ordered quantity within 75 days from the date of issue of GeM contract.
- 4. 3rd installment of 35 % of total ordered quantity within 105 days from the date of issue of GeM contract.

Note:

- 1. Sample testing on the machine of the supply will be done on random basis.
- 2. If any roll found not meeting the requirement on machine due to substandard material or not meeting the specification, then it will be rejected. The supplier has to replace the rejected material with good supply at his own risk and cost (As the inspection/quality testing will be carried out on random sample basis).
- 3. The allowable periodic variation would be \pm 1.5%. Under no circumstances, material will be accepted bey ond \pm 5% allowed quantity tolerance. Any variation in periodic rate of supply more than \pm 5% in each delive ry schedule would be considered as delay in delivery and LD will be imposed on such short supply in which quantity is beyond \pm 5% of each delivery.

- 3. Sealed and Signed GeM Bid (Tender) Document.
- 4. Sealed and Signed technical specification of the tendered product (attached in the Bid Document.)
- 5. Undertaking/Declaration certificate mentioning that you are currently not suspended/Banned/Blacklisted by any ministry/department of govt. of India or by any state govt. for business dealing.
- 6. Undertaking/declaration certificate of land border share as per point no. 20.
- 7. Undertaking that bidder has read and accepted all clauses of GIT and GCC should be submitted.
