- **2) Authorized Representatives:** Bids of bidders quoting as authorised representative of a principal man ufacturer would also be considered to be qualified, provided:

Note: The allowable periodic variation would be +/-5%. Under no circumstances, material will be accepted beyond +5% allowed quantity tolerance. 12. **Quantity Tolerance:**

The seller shall be allowed a tolerance of \pm 0.5% on the ordered quantity. This tolerance is to simplify logist ical constraints and accounting of material. If any default or harmful effects are discovered after the utilization of the medicines or drugs, appropriate action will be taken against both the reseller and the brand, as per the latest memorandum from the Drug s Authority.

14. Other Criteria for bidders:

- a. The bidder must hold a valid Drug License issued by the respective State Licensing Authority or Central Licensing Approving Authority, wherever applicable.
- b. **Brand New Supply**: The supplier is required to deliver a brand new lot of medicine and drug items. Used, old, or expired items will not be accepted.
- c. **Replacement of damaged consignment** Any damaged consignment, whether detected on a piece-to-piece basis or carton-wise, must be replaced by the supplier without any additional cost to the Purchaser. Replacements should be made promptly upon notification.
- d. **Batch Number on Each Box**: Every box in the consignment must clearly display the batch n umber. Failure to provide batch numbers may lead to rejection of the consignment.
- e. **Rejection of opened or unboxed consignments** Any consignment that arrives opened, c ut, or unboxed will be automatically rejected. The supplier must ensure that the packaging is intac t upon delivery.
