If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Certificates

2. The bidder firm should meet following eligibility criteria to qualify:

- (a). For MSE / Startup firm: Capability Equipment & Manufacturing Facilities: The bidder firm must have capability to Manufacture and supply tendered item.
- **(b). For Other firm: Experience and Past Performance:** The bidder firm may be Manufacturer/Proven supplier/ Authorized dealer or distributor of tendered item or bidder may participate with manufacturing a uthorization form (issued by manufacturer of tendered item).
- **3. Shelf Life :** The bidders has to submit the undertaking that shelf life of the material shall be minimum 12 months from the date of supply of material at BNP Dewas.

4. Delivery schedule:-

Past supplier of BNP Dewas-The firm on whom supply order will be placed will have to supply the mat erial in 02 installments as mentioned below:-

- -1st installment of 50% of total ordered quantity to be supplied within 30 days from the date of placing Co ntract.

Note:-

- i. Pre-production sample to be submitted for testing only after issue of formal GeM contract/P.O. Firm shall not submit any sample for testing before issue of the formal GeM Contract/P.O.
- ii. Purchaser's sample: After submission of security deposit and issuance of GeM Contract/ P.O., successful b idder may collect the purchaser's sample (Pill Box Sample) from Bank Note Press, Dewas for guidance. The successful bidder will have own responsibility to collect the sample from Bank Note Press, Dewas. However it should not affect the delivery schedule of the material.
- iii. The pre-production sample should be 2 KG quantity of single lot having single batch no./lot no.
- iv. In case of failure of the first pre-production sample, one more chance may be given if the first sample do es not come up to the contract requirement. However this shall be done without rescheduling of delivery ti me. The firm shall submit second pre-production sample within 15 days from the date of communication of rejection of first sample. In case of rejection of second pre-production sample, no further chance for submi ssion of another pre-production sample will be given.
- v. All supplies including pre-production samples must be received at BNP along with MSDS and Certificate o f Analysis (COA) from suppliers' end, failing which, the supplied lot/sample shall be rejected.

5. Warranty clause:

- a) The supplier warrants that the goods supplied under the contract is new, unused, and incorporate all rec ent improvements in design and materials unless prescribed otherwise by SPMCIL in the contract. The sup plier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as per SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
- b) This warranty shall remain valid for **twelve months** after the goods or any portion thereof as the case m ay be, have been delivered to the final destination and installed and commissioned at the final destination and accepted by SPMCIL in terms of the contract.
- c) In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- d) Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, wh atsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.
- e) In the event of any rectification of a defect or replacement of any defective goods during the warranty pe riod, the warranty for the rectified/ replaced goods shall be extended to a further period of **twelve month s** from the date such rectified / replaced goods starts functioning to the satisfaction of SPMCIL.
- f) If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable period (or wi thin the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without prejudice to other contractual rights and re medies, which SPMCIL may have against the supplier.

6. Liquidated Damages:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SP MCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the $\frac{1}{2}$ 9% percent of the delivered price of the delayed goods and/ or services for each week of delay or part there of until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

7. **Quantity Tolerance**: The seller shall be allowed a tolerance of \pm 0 on the ordered quantity. This tol erance is to simplify logistical constraints and accounting of material. If seller supplies quantity beyond tol erance limit (except quantity procure through option clause) then such material shall not be accepted and no payment shall be made for such supplies. Also if seller supplies less quantity than tolerance limit within stipulated delivery period then it shall be consider as supply shortfall.

Further it is to be noted that payment shall be made for quantity actually received and accepted by BNP D ewas.

- **8.Anti-bribery Clause:** By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happ ening, they shall report it to Vigilance.
- 9. **GIT & GCC:** Bidders are requested to go through link provided below regarding GIT (General instruction s to Tenderer) & GCC (General conditions of contract) and submit an undertaking that bidder has read & u nconditionally accepted all the clauses of GIT & GCC. In case if there is any contradictory provision betwee n GeM GTC and SPMCIL GIT & GCC then provision given in GIT & GCC of SPMCIL shall prevail.
