The bidder must have completed at least one similar environmental monitoring assignment (stack/ambient/DG set/incinerator monitoring) for any Government Department/PSU/Autonomous Body/Industry during the last five years ending on 31.03.2025.

## 3. NABL Accreditation:

The bidder must either have an in-house NABL-accredited laboratory, or have a valid MoU/Agreement with a NABL-accredited laboratory. The accreditation must include relevant parameters such as PM<sub>2.5</sub>, PM<sub>10</sub>, SO<sub>2</sub>, NO<sub>x</sub>, CO, and SPM.

## 4. Instruments & Calibration:

All instruments to be used for measurement shall comply with CPCB norms, and shall have valid calibration certificates traceable to NABL/NPL laboratories.
