1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be

2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Scope of Supply

2. The participating firm has to submit sealed and signed bid document as an acceptance of all additional terms and conditions, technical specification and payment terms as mentioned in bid.

3. LD Clause: If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

4. "GST Return: Supplier should file the GST returns for outward supplies in time. In case of any Input credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."

5. Capacity verification (if required): As part of technical evaluation, if required capacity verification of the bidders may be conducted by BNP. The offer of the firms not meeting the criteria in verification as per bid document will be rejected.

6. Warrantees Clause: The warranty shall be applicable only for 3 months from the date of last supply/delivery. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable period, BNP may proceed to take such remedial action as per the SPMCIL procurement manual.

7. Anti Bribery Clause: "By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance."

Accordingly bidders are requested to obtain these certification to ensure minimum wastage in production process which shall ultimately result in cost cutting & improvement in efficiency.

11. The bidder firm should meet following eligibility criteria to qualify:-

(a) For MSE/Start-up firm: Capability - Equipment & Manufacturing Facilities:

The bidder firm should have capability to manufacture and supply of tendered item.

12. Delivery Schedule - The successful firm has to supply 40 kgs of rolls within 30 days from the date of issue of GeM contract for trial and suitability. (No payment will be made for un-suitable & consumed rolls during pre-production trials).

After confirmation of suitability of trial rolls within 10 days from BNP, the firm have to supply the material as per below schedule :

Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.






Specifications of 1000 Band rolls (BOPP film)- 40 mm width


Description	: BOPP Band Film
Width	: 40 mm (Should not exceed 40 mm)
Colour	: Transparent
Thickness	: 52 ± 2 Micron (Uniform throughout)
Band Sealing Temperature	: 130°C to 160°C
Maximum Outer Dia. Of Roll	: 320 mm
Hard Card board core Inner Dia.:	120 mm
Hard Card board core Outer Dia.:	140 mm
Weight of Roll	: 2.0 - 2.2 Kg
Unit of Measure	: Kg.
Finishing	: It should be ensured that there are no joints in the roll. The two overlapped portions of the film, when brought in contact with sealing heater at sealing temperature should get firmly sealed together.
Packing	: a) The starting point of film should be glued only. b) Inner cardboard core should be exact to the width of the roll. c) Packing should be robust enough to protect the core of the rolls from crumbling during transportation and storage. d) Core shall be protected by providing suitable core plugs.
