Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GEM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

e) **Anti-bribery Clause:** By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.

**3. The bidder firm should meet following Eligibility Criteria to qualify:**

A. **Experience & Past Performance:** The bidder should have experience in providing similar kind of service at an ordered value of Rs. 31,41,773/- and currently also they should be in the business and should have executed contracts for a minimum value of orders in any one year during last Five years ending with 31.03.2025.

“Similar kind of services” means Trucks transportation of- WMP(Watermark Paper)/ Currency Notes/ Printed Bank Notes/Coins to Regional Offices of RBIs/Currency Chests/Banks / Presses / Mints anywhere in India.

B. **Capability, Equipment and Manufacturing Facilities:** The bidder should have capability to provide the relevant services.

C. **Financial standing:**

(i) The Average Annual Turnover of the Bidder firm during last three years ending on 31st March 2025 should be more than Rs. 31,41,773/-

(ii) The net worth of the bidder firm should:-

a) Not be negative on 31st March 2025

b) Not have eroded by more than 30% in the last three years, ending on 31st March 2025.

**Note:** MSEs and Start-ups are exempted from Eligibility Criteria 3(A) & 3(C). However, documents regarding 3(B) shall be verified.

D. Further below mentioned additional documents to be submitted by all eligible firms:

(i) A certificate towards IBA approval.

(ii) Bidder should be registered under “The carriage by Road Act 2007” and have valid certificate for the same. Copy of certificate issued by RTO to be enclosed. (Government/ PSUs are exempted from this registration)

(iii) The bidder should submit “Confidentiality statement” on their letter head duly signed by the legally authorized signatory and sealed that “The information, which is contained in this document will not be, in whole or in part be reproduced, transferred to other documents/electronic media or disclosed to others without written consent of BNP, Dewas. **Applicability in Special Cases:-**

1) **Applicability to ‘Make in India’:** Bidders (manufacturer or principal of authorized representative) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided:

i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and

ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content.

iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of ‘The Product’ offered

d including all warranty obligations as per the general and special conditions of contract.

**2) Authorized Representatives:** Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided:-

- a. their principal manufacturer meets all the criteria above without exemption, and
- b. the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and
- c. the bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 'The Relevant Date'.

**3) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL. (This clause is not applicable for Security Items as notified by Government of India from time to time.)

**4) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

**5) Development/ insufficient market capacity or Exceptional One-Off Cases:** These are those items which are either being newly developed where vendors are yet to be developed or for new/ existing items where the capacity available in market is inadequate compared to our annual requirements. Exceptional one-off cases are such items/ Plant & Machinery which are procured infrequently (say once in 3 years or longer periods). In such cases PQC Should be Decided with the approval of CFA in individual cases.

**6) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Start-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

#### **4. Liquidated Damages:**

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the  $\frac{1}{2}$  percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

#### **5. GST Return:**

Supplier should file the GST returns for outward supplies in time. In case of any Input credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."

**6. ZED & LEAN Certification:** Government of India has launched scheme for obtaining ZED & LEAN certification to MSE vendors. Accordingly bidders are requested to obtain these certification to ensure minimum wastage in production process which shall ultimately result in cost cutting & improvement in efficiency. For further clarification & assistance bidders are requested to go through website of ZED & LEAN certification scheme, links of which are as follows:

#### **7. GIT & GCC:**

Bidders are requested to go through link provided below regarding GIT (General instructions to Tenderer) & GCC (General conditions of contract) and submit an undertaking that bidder has read & unconditionally accepted all the clauses of GIT & GCC. In case if there is any contradictory provision between GeM GTC and

**8. Statutory Compliance :** The Contractor shall make all statutory payments like Minimum Wages, EPF, and ESI to their deployed Workmen (Drivers) as per the notification published by Central Govt. / State Govt., whichever is higher from time to time, besides paying all other statutory payments. The workmen (Driver) should be paid the minimum wages under the Minimum Wages Act, 1948 & rules made thereunder, Contract Labour (R & A) Act 1970 & Contract Labour R & A Rules 1971, payment of wages act 1936, and other related labour legislations etc., including any enactment made by the government or modification thereof or any other laws relating to there to & rules framed there under from time to time and shall by periodical substitution/ rotation of manpower, Besides, the workmen (Driver) should be given Employees Provident Fund as per EPF Act 1952, Bonus and / or dividends as per Payment of Bonus Act 1965 and ESI under ESI Act. In the absence of ESI, the Contractor should undertake the liability under the coverage of Insurance such as Workmen's Compensation Insurance under W.C. Act, 1923. The total premium shall be borne by the Contractor. The Contractor shall have a valid PF Account for making PF Contribution for their Workmen (Driver). In case of any complaint regarding noncompliance of any statutory payments; the same shall be deducted from the bill without prejudice to the Company's right to cancel the contract. The Contractor have to maintain all records and legal documents up dated as per prevailing statute and have to produce before the management / statutory authorities as and when asked for. Besides, the Contractor has to indemnify the Company from all types of legal implications due to any negligence on their part and for which the Bank Note Press, Dewas is not responsible.

## TECHNICAL SPECIFICATION & SCOPE OF WORK

### 1. Nature of work

1.1 Transportation of security sensitive product from Bank Note Press, Dewas, (MP) in closed metal body containers by road to various destinations (RBI Bhopal, Ahmedabad & Jaipur) located across India with front and rear escort vehicles.

1. 20ft. container (09-12 MT capacity)
2. 40ft. container (27-29 MT capacity)
3. Escort vehicles of 8 seater capacity (A/C with head rest) for to & fro journey.
4. Escort vehicles of 12 seater capacity (A/C) for to & fro journey.

### 2. Scope of work

2.1. The security product should be transported on a regular basis as per monthly tentative schedule intimated in advance by BNP, Dewas in the beginning of every month. However, the schedule may change at any moment of time with a prior intimation to the Contractor. The Contractor shall be ready to supply the container trucks at any time.

2.2 The monthly schedule shall only intimate the probable number of vehicles required on particular dates, however the destination / place of visit shall be kept confidential. The same shall be intimated at the time of dispatch only. Hence, the vehicles should be roadworthy and express fit, for long distance journey during each trip.

2.3 Loading at the origination point as well as unloading at destination will be arranged by BNP / RBI center.

2.4 The Fully closed trucks / containers have to travel from BNP to the destination RBI centers/other centers through main route / State / National highways / Expressways or as instructed by the CISF security or BNP Officials.


2.5 Time of arrival at BNP of all vehicles on the date of dispatch & timing of dispatch of consignment from BNP shall be intimated on the same day or 1 day prior as per our requirement.

2.6 BNP being a security organization has security and confidential norms, which will be binding on the Contractor. The vehicles and its drivers should undergo security check & other formalities.

2.7 After unloading and relieving by concerned RBI center/destination, the container truck will be at the sole disposal of Contractor.

### 3. Closed Metal body container/Trucks

3.1 The Vehicles to be supplied for carrying the security materials must be in excellent working condition and should be available at a short notice. The containers should be fit for movement on highway at high speed (about 70-80 kmph with full load). Besides, completely

### **1. Contract Duration**

1.1 The rate contract will be placed for a period of 12 months from the date of Contract.

1.2 However the schedule of deployment of the vehicles will be intimated as and when required by BNP, Dewas as per the provisions mentioned in Technical Specification / Scope of work.

1.3 The monthly tentative schedule will be given by BNP at the start of the month for requirement of number of vehicles only. The destination shall be kept confidential. The same shall be intimated at the time of dispatch only.

1.4 The probable destinations to which the Vehicles / escort has to be provided are as under:

1.5 All the above trips are tentative. The requirement may vary between the type of vehicle as well as the destination from time to time. The tentative requirement of type of vehicles for a month will be given in advance, but destinations will be informed only up on loading of the consignment.

closed metal body trucks should have proper arrangements to prevent any threat of pilferage or other security and safety hazards, while in transit.

3.2 The Fully closed trucks/containers should have metallic body of sufficient thickness, tamper proof with secure tamper proof locking facility (traditional i.e. two Padlock (lock and key), two OTL (One-time lock) [Total Four Locks]. The locking rod of the door must engage the top & bottom of the vehicle/truck.

3.3 The vehicle/truck with detachable/portable container should be fit to carry a minimum of 09-12 MT load for 20 ft container and 27-29 MT load for 40 ft. container, so as to transport boxes of various sizes & weights. The driver's cabin/Prime-mover should preferably be AC.

3.4 The fully closed trucks/containers should have a separate passenger compartment from the cargo compartment desirable with high resolution CCTV coverage. The recordings of these CCTV cameras should be subjected to periodic sample checks for retrievability. The contractor/service provider has to ensure start to end recording of the CCTV footage and immediately hand-over the recordings to PR in portable media from the Main storage after completion of Unloading at destination. The portable media should be handed over to PR in a sealed cover jointly signed by CISF Escort Party In-charge and PR. The original CCTV contents / recordings should be deleted from the main storage in the presence of CISF/PR. Portable media will be provided by BNP.

3.5 Containers should have a removable hooter, to be used as desired / required.

3.6 Two guides, one on each door shall be provided in each opening of the container as anti-pilferage device. The containers shall be secured to the trailers by means of twist locks in order to prevent them from capsizing, while in transit.

3.7 The base/surface on which the box will be loaded should be plain & without dents/obstruction. This should facilitate easy movement of boxes by sliding.

3.8 Each Truck/Container should be fitted with GPS tracking system by the transporter, whereby it can be tracked through App/Internal Browser by the Bank/the press/the law enforcement agencies/the Contractor at any time and separate User Id/Password should be given to each agency. These vehicles should be monitored live with geo-fencing mapping with the additional indication of the nearest police stations in the corridor for emergency. Rate quoted in price schedule will be inclusive of charges for GPS system, no separate payment for GPS system shall be made.

3.9 In case of complete immobilization of the vehicle, the 20 feet/ 40 feet vehicle should have a provision for separation of prime mover and trailer / container. Inbuilt Hydraulic Jack for Lifting the trailer with load to be provided for easy replacement of Prime-Mover. Container to be placed on a checker sheet bed placed on the trailer. The driver's cabin/Prime- mover should preferably be AC.



3.10 The detachable/portable containerized vehicles should have tubeless tyres and in case of any puncture/damage of Tyre, it should be replaced within half an hour. Also sufficient number of Spares Tyres [Stepney] in serviceable conditions shall be available on the vehicles before commencement of journey. First Aid Kit, Portable Fire Extinguisher shall be fitted with state of art fire- fighting equipment which should be serviced regularly and maintained in good condition, Heavy Duty Torch, etc. for emergency purpose.

3.11 All the vehicle drivers accompanying the vehicles have to abide by all security norms right from entering our premises for carrying the security materials till the issue of clearance certificates by respective in-charge/ authority of different destinations.

3.12 The Contractor should comply with all statutory requirements like valid insurance, insurance coverage, road taxes, Fast Tag, Pollution Certificate and permits for inter-district and inter-state movements etc.

3.13 The proposed vehicles should have enough space and provision in drivers Cabin for seating of escort personnel. The cabin doors must have locking facility from inside.

3.14 The entire vehicle to be provided shall have comprehensive insurance policy and valid National RTO permit with required Fitness Certificate.

#### **4. Age of Vehicles**

4.1 The trucks with detachable/portable container to be provided should not be more than (02) Two-year-old as on the effective date of Work Order/Contract. The vehicles should be in absolute fit working condition, duly registered with R. T. O with all taxes paid, all the valid documents, insurance and national permit from statutory authorities. The contractor shall submit the ownership certificate of at least 2 nos. of trucks/ containers of 40 ft MXL 27-29 MT loading capacity trucks OR at least 4 nos. of 20 ft. trucks/ containers 09-12 MT loading capacity excluding container and vehicle's weight which should not be more than two year old from the date of floating of tender to utilize same containers considering Security aspects and availability. The Trucks/ containers/ wheels / Tyres condition should be suitable for the specific roads / State / National highways and expressways etc.

#### **5. Drivers**

5.1 The contractor shall arrange sufficient number of experienced (min. 5 years) drivers atleast 2 in each vehicle for continuous movement for truck & escort vehicles. Driver should be skilled, competent, matured, medically fit and having a valid professional (Commercial) driving license issued by a Competent Authority. Apart from being sober, gentle, courteous and well-behaved person with at least one year working experience in any reputed Organization. Their



character and antecedents should be verified by the police authorities. If a particular driver's performance/conduct is not acceptable to the Company, he must be replaced within 3 days. In case of being in intoxicated condition, indiscipline on the part of driver, he should be replaced immediately as this is life-risk and detrimental to the safety of the organization.

5.2 All the vehicles drivers and other personnel accompanying the vehicles have to abide by all security norms right from entering our premises for carrying the security materials till the issue of clearance certificates by respective in-charge/ authority of different destinations.

5.3 The age of Drivers shall be preferably below 45 years. They should be medically fit for long distance driving. Fitness certificate shall be produced before the journey, as and when required.

5.4 The Contractor should ensure that none of the drivers has any criminal background. The Contractor should take necessary steps before their employment for verification of character & antecedent from Police authority and copy of police verification should be submitted to BNP. Their identity proof should be obtained such as voters ID card, Ration card, etc. This information should be current and not more than a year old. The Contractor should also submit the filled bio-data of the drivers in the prescribed bio-data form countersign the same for authenticity and submit the same to BNP.

5.5 The Transporter must comply with Motor Vehicle Act & other provisions of Law and rules as applicable to road transportation service.

5.6 The Contractor shall obtain license / registration from Labour Authority / any other Statutory Authority including PF & ESI as may be required and shall furnish Statutory Returns and deposit contributions and Statutory Levies as per the Law of the Land as applicable from time to time. The Contractor shall be liable to furnish to the Company all copies returns and documents as would be asked for time to time.

5.7 Any untoward incident arising out of improper supervision or inadequate safety measures and loss / damage/ compensation arising out of this will be the sole responsibility of the transporter. The transporter should properly maintain all necessary first-aid kits under his custody and ensure that all its employees are adequately trained in administering first-aid in case of emergencies.

## **6 General conditions**

6.1 In case of complete immobilization of the vehicles due to any reason suitable alternate vehicle to be provided to transfer the security material from the place of incident to the destination in one trip within the quickest possible time and expenses related to unloading from the malfunctioning vehicle and loading to the another vehicle will be at Contractor's account.

6.2 The Contractor has to ensure that alternative drivers are provided for non-stop road movement of all the vehicles to meet the time schedule. All the drivers shall take movement orders from Company's Security Officer accompanying.

6.3 In case of changing driver en-route in exigency the permission shall be taken from BNP. The documents of the new driver will be verified by Press Representative and CISF in-charge.

6.4 Route for destination shall be specified by the Company only after completion of loading and should be kept strictly confidential by the Contractor / his representative / drivers.

6.5 Either Contractor or his/their representative should interact with the Company on a day-to-day basis for the requirements / movements of vehicles.

6.6 All security norms are to be followed by the truck driver and other personnel accompanying with the vehicle. Besides, it is prerogative of Company to decide how many security personnel will be posted in each vehicle.

6.7 In case the Contractor fails to supply the required number of vehicle/trucks at specified date and time, alternative arrangement will be made by BNP at the risk and the cost to the Contractor.

6.8 The Driver of the vehicle should carry valid Driving license, Registration Certificate, Insurance papers, necessary road permits, and Emission certificates at the time of placement of vehicle at our premises.

6.9 The Contractor shall not engage any sub-contract or transfer the contract to any other person,

6.10 Drivers must be provided with a Mobile Phone by the Contractor and adhere to the security protocols of convoy instructed by BNP / CISF personal.

6.11 The Contractor should strictly instruct the staff that during the movement of consignment no photographs should be taken and mobile phones should not be used while driving. For non-adherence of the same, the agency will be held responsible on the account of breach of security.

6.12 All apps related to social media viz. whatsapp, Facebook etc. must be kept in disabled state during journey period. No information related to consignment should be shared in the social media including own location even via text message.

6.13 Information about any untoward incidents should be shared only on need-to-know basis and due confidentiality must be maintained.

6.14 Timely transportation & delivery is the essence of this work due to sensitive nature of the cargo. The transporter should adhere to the time schedule as given by BNP for placing the vehicles at the origination point, the estimated normal transit time including normal and minimum stoppages and arrival at the destination such as to adhere to the working time schedule of the consignee RBI Center.

6.15 In exceptional case, for any last hour cancellation of scheduled consignment due to any unavoidable reasons, No charges will be made



by BNP for such non-utilization of vehicles (e.g. driver charges or vehicle detention charges etc.).

6.16 The fuel tank of the vehicle is to be kept full or which shall be sufficient for at least 250Kms per day. Time consumed / mileage required for intermediate refilling shall not be taken into account.

## **7. Escort Vehicles**

7.1 Two escort vehicles are required at a time for the movement of maximum two containers. One escort vehicle is 8 seater and the other one is 12 seater.

7.2 Emission Standard- BS VI onward Compliant with minimum 1500 CC Engine Capacity diesel engine; 8 & 12 seater, Air Conditioned, with Power Steering, Tubeless Tyres. 02 Nos Escort Vehicles will be required for a single journey at a time per remittance and should be roadworthy with not more than (02) Two-year-old as on the effective date of Work Order/Contract.

7.3 The Escort Vehicle should have a removable red light on top hood & hooter to use in an emergency.

7.4 The Escort Vehicles should have front doors in left and right side of the vehicle for entry and exit of passengers in addition to rear entry /exit.

7.5 All the Vehicles shall be provided with GPS by the Service Provider/Transporter.

7.6 Sufficient number of Spare Tyres [STEPNEY] in serviceable conditions shall be available on the vehicles before commencement of journey.

7.7 The vehicles should have the required insurance, insurance coverage, road taxes, Fast Tag, Pollution Certificate and permits for inter-district and inter-state movements. The vehicle should be registered with BS VI onward and kept in excellent up-holstery & running condition at all times, along with the medically fit two nos. (02) Skilled driver with valid commercial driving license for each vehicle to travel long distances.

7.8 The vehicles should be available at a short notice say within 3 - 4 hours or even less on our notice over e-mail/ Fax / telephone. Whenever excessively more number of vehicles are required, then intimation will be given well in advance to the service provider.

7.9 The proposed vehicles should have adequate numbers of spare Tyre/s in serviceable conditions and in case of any puncture/damage of tyres, it should be replaced within an hour. Also, other provision like First-Aid Kit, Portable Fire Extinguisher, Heavy Duty Torch and provision for power charger for mobiles / Motorola / walkie-talkie hand-set and GPS etc. for emergency purpose should be available in escort vehicles.

7.10 The Log Books for duty of the vehicles will be recorded from / to BNP on each trip basis and records duly authenticated should be shown on demand.

7.11 The owner / service provider should ensure that the vehicle as well as the driver should comply with all statutory obligations like Road tax, Pollution certificates, insurance coverage, valid commercial driving license, residential and identity proof etc. together with permits for inter-state movements, etc. The Vehicles/ wheels / Tyres condition should be suitable for the specific State / national highways or expressway etc.

7.12 The Escort Vehicles (8 seater & 12 seater) should be capable of moving with the speed of trucks.

7.13 The Escort Vehicles may have to halt overnight at the specified destination till the completion of unloading or up to relieving of CISF Escort /Press Representative or reporting back at the BNP. The vehicles should have All India RTO permits with yellow number plate.

#### **8 Insurance in respect of damages to the persons & Property**

8.1 Before commencing the execution of works, the successful transporting agency without limiting his obligations and responsibilities under his contract shall insure against his liability for vehicles, any material or physical damage, loss or injury which may occur to any property, including BNP to any person including any employee of the BNP or a member of general public, by or arising out of the execution of the works or in carrying out the contract. It shall be obligatory for the transporter to obtain relevant insurance policies.

8.2 Compensation for Damages: The successful transporting agency shall be responsible for any damage to any person, tools & tackles, animal or property arising out of and incidental to the negligent or defective carryout of his contract. He shall also indemnify the BNP in respect of any costs, charges or expenses arising out of any claim or proceedings and also in respect of any award of compensation or damages arising there from BNP shall be entitled to deduct the amount of any damage, compensation, charges, costs and expenses arising or occurring from or in respect of, any such claims or damage from any or all sums due or to become to the agency without prejudice to BNP's other rights in respect thereof.

8.3 STRICTLY CONFIDENTIAL: The details of goods and other particulars and movement shall be kept confidential by transporter and shall be known only to consignee or their representatives.

8.4. Goods to be transported being high value, proper care should be taken while handling and transportation to avoid tampering of containers, any pilferation, damage etc.

8.5. Transporter shall quote for transportation charges per consignment including all other incidental charges, detention charges, other fee's etc.

8.6. The transporter shall ensure proper closure of doors of the containers at the time of loading/shifting.

8.7. In case of long road transportation, events like imposition of restrictions on movement by State Government authorities on a particular route or in certain timings or diversion of routes on



temporary basis due to civil works, law and order situation, festivals, etc. shall form the basis for claiming per km price for additional km.

8.8. In case of any break down or any difficulties, immediate information shall be conveyed to nearest police station and also to the consignee.

8.9. CONTRACTOR's OBLIGATIONS WITH REGARD TO ROAD TRANSPORT SERVICES: The contractor engaged to transport containers through road vehicles will observe and abide by all the statutory laws and rules, including safety norms, made by central/State Governments in regard to transportation from time to time. Request for additional payment will not be entertained at later stage, if contractor do not abide by laid down laws. The transporter has to quote accordingly.

8.10. Expeditious Movement of containers: The Transport Contractor shall carry out the various activities assigned to him under this contract expeditiously within the time prescribed by BNP. Transport Contractor should provide adequate/sufficient number of trailers/vehicles for coping up with job order requirement and its timely compliance. Failing which damages shall be applicable as per under mentioned clauses.

8.11. Vehicle deployed must be fit for meeting with the stipulation of weight categories as indicated in Motor Vehicles Act and all State and Central Laws. Contractor will indemnify BNP for any fines / penalties imposed by any Authority for his act of violation of any of such laws.

8.12. INDEMNITY: The successful bidder/ Contractor shall at all times indemnify BNP against all claims which may be made in respect of the stores for infringement of any right protected by patent, registration of design or trade mark and shall take all risk of accidents or damage which causes a failure of the supply of goods / Services.

8.13. SUBLetting OF THE CONTRACT: The transporter shall not sublet, transfer or assign the contract as a whole or part thereof to any other firm.

8.14. TRANSIT INSURANCE: SPMCIL shall arrange the TRANSIT Insurance coverage for the security material to be transported. However, the transporter is liable for all transit risks as per the liability regime defined in relevant Act concerning Road transportation.

#### **9 Penalty clause**

9.1 A penalty at the rate of Rs. 1000/- per hour beyond 02 hours delay for placing vehicle at BNP will be deducted from the invoice at the discretion of the Company.

9.2 In case of any breakdown of the vehicle, the Contractor has to arrange a substitute vehicle within 04 hours' time, failing which a penalty of 10% per hour, maximum up to 40% per vehicle (of invoice

amount) will be levied. No penalty will be levied if delay is due to enrooted law and order problem.

#### QUALITY CONTROL REQUIREMENTS

The contractor should maintain all the quality, fitness, insurance certificates of the vehicles provided for the said work. Also should maintain the record of the Police verifications, character and antecedent certificates of the drivers deployed for the said work. A copy of all the said certificates along with the Indemnity bond only for remittance trucks to be submitted by the Contractor before starting of the work.
